A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS NECESSARY TO ENTER INTO AN AGREEMENT WITH THE LOS ANGELES COUNTY FLOOD CONTROL DISTRICT AND TO ACCEPT AND EXPEND FUNDING FOR THE RESERVOIR PARK STORMWATER CAPTURE PROJECT FROM THE SAFE CLEAN PROGRAM'S REGIONAL PROGRAM TRANSFER AGREEMENT NO. 2024RPLSGR03

WHEREAS, on June 9, 2020, the Los Angeles County Board of Supervisors approved the Safe, Clean Water (SCW) Program Transfer Agreement (TA) template for the Regional Program which will need to be executed between the City of Signal Hill (City) and the Los Angeles County Flood Control District (District); and

WHEREAS, the Regional Program is designed to maximize the ability of the agencies to address regional stormwater and pollutant load challenges and improve water quality in the region by establishing a competitive funding source that benefits multiple jurisdictions; and

WHEREAS, projects and programs are required to include a water quality benefit; multi-benefit projects and nature-based solutions are strongly encouraged; and

WHEREAS, the Reservoir Park stormwater project achieves several stormwater quality objectives including adding infiltration capacity, improving water quality, and reducing pollutant loads in the Lower San Gabriel Watershed; and

WHEREAS, Lower San Gabriel Watershed Area Steering Committee (WASC) recommended approval of the Stormwater Investment Plan (SIP) incorporating a \$6,676,878 funding allocation to the City of Signal for the delivery of the project; and

WHEREAS, On October 22, 2024, the Los Angeles County Board of

Supervisors approved the SIP allocations as recommended; and

WHEREAS, the District's policies and procedures require the governing

body of the City of Signal Hill to authorize an appointed representative to execute a

transfer agreement and submit to the District for processing of the final draft agreement;

and

WHEREAS, said application contains assurances that City of Signal Hill

must comply with; and

WHEREAS, City of Signal Hill will enter into Agreement with the District to

provide funds for the Reservoir Park Stormwater Capture Project as identified in the SIP

and scope of work within the agreement.
