WHEREAS, on September 30, 2021, Governor Newsom signed into law

Assembly Bill 481 ("AB 481") to address the funding, acquisition, and use of military

equipment, as that term is defined by Government Code § 7070(c), by law enforcement

agencies; and

WHEREAS, AB 481 seeks to provide transparency, oversight, and an

opportunity for public input on decisions regarding whether and how military equipment

is funded, acquired, or used; and

WHEREAS, Ordinance 2022-06-1535 shall be reviewed by the City Council

at least annually, and based on an annual military equipment report that will be submitted

to the City Council pursuant to AB 481, the City Council shall determine whether each

type of military equipment identified in the report has complied with the standards for

continued approval.

WHEREAS, in accordance with AB 481, an annual military equipment

report was made available on the website on the Department website at least thirty (30)

days prior to the City Council meeting; and.

WHEREAS, in accordance with AB 481, the Policy is on the agenda as an

open session item at a regular meeting of the City Council, and public comment on the

item will be allowed in accordance with the Brown Act; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. Approve the 2024 Military Equipment Annual Report

<u>Section 2.</u> Renew Ordinance No. 2022-06-1535 thereby approving the Police Department's military funding, acquisition, and use policy.
