MINUTES OF A REGULAR MEETING SIGNAL HILL CITY COUNCIL February 10, 2026

A Regular Meeting of the Signal Hill City Council was held in-person in the City Council Chamber on February 10, 2026.

a. UPDATE ON REQUIREMENTS OF SENATE BILL 707

City Attorney Richardson provided a presentation on Senate Bill 707, highlighting the requirements for two-way audio or audio/visual communication during City Council meetings, the need to adopt a policy regarding potential technological disruptions, make findings that language translation requirements are not applicable, and update the agenda language to inform the public how they may participate remotely. Mr. Richardson stated staff would return to the Council within the next two months with the necessary implementation actions, ensuring everything was complete before the July 1st effective date.
