## (12) <u>CITY MANAGER REPORTS</u>

a. CONTINUANCE OF THE PROCLAMATION OF THE EXISTENCE OF A LOCAL EMERGENCY IN RESPONSE TO THE FEBRUARY 2024 WINTER STORMS, A RESOLUTION AUTHORIZING AN EMERGENCY PUBLIC WORKS CONTRACT FOR THE REPAIR WORK AT PANORAMA PROMENADE TRAIL AND MOLINO AVENUE AND 20TH STREET, AND APPROVAL OF GENERAL SERVICES AGREEMENT WITH ZIMPRICH ENGINEERING INCORPORATED

It was moved by COUNCIL MEMBER HANSEN and seconded by VICE MAYOR WILSON to authorize the City Manager to extend the proclamation of the existence of a local emergency in response to the February 2024 winter storms for 60 days; adopt Resolution No. 2024-02-6784, by four-fifths vote, to find that the public interest and necessity demand the immediate expenditure of public money to safeguard life, health, or property and that the City may take immediate action required by the emergency, including procuring the necessary equipment, services, and supplies for those purposes, without giving notice for

bids to let contracts to complete the emergency repair, to be completed within the scope of the agreement with the contractor, for the storm damage at the Panorama Promenade Trail and Molino Avenue and 20th Street; and authorize the City Manager to enter into a General Services Agreement with Zimprich Engineering Incorporated for a not-to-exceed amount of Four Hundred Thirty-One Thousand Nine Hundred Ten Dollars (\$431,910) for work pertaining to Panorama Promenade Trail and 20th and Molino Avenue Slope emergency repair projects.

b. HILLBROOK PARK IMPROVEMENT PROJECT (PROJECT NO. 80.23007)

It was moved by VICE MAYOR WILSON and seconded by COUNCIL MEMBER JONES to authorize the City Manager to enter into a Public Works Contract with Green Giant Landscaping, Incorporated, for the construction of the Hillbrook Park Improvement Project (Project No. 80.23007), for a term of 120 working days and a not-to-exceed contract amount of \$1,799,000 in a form approved by the City Attorney; authorize a contingency of \$60,000 to accommodate additional scope of work, changes, or any unforeseen conditions, to be utilized if approved by the Public Works Director, for a total construction budget of \$1,859,000; authorize the City Manager to execute the Member Agency Administered Program Reimbursement Agreement in a form approved by the City Attorney; and adopt Resolution No. 2024-02-6785 amending the adopted budget and authorizing budget appropriations for Fiscal Year 2023-24 to increase the Capital Improvement Project and record new funding sources.
