a. PROFESSIONAL CONSULTANT SERVICES AGREEMENT WITH MINAGAR & ASSOCIATES, INC. (M&A) FOR LOCAL ROADWAY SAFETY PLAN (LRSP) DEVELOPMENT SERVICES AND AUTHORIZATION FOR STANDARD CONTINGENCIES

It was moved by COUNCIL MEMBER COPELAND and seconded by VICE MAYOR HANSEN to authorize the Interim City Manager to enter into a Professional Consultant Services Agreement with M&A to prepare the LRSP and provide grant funding advisory services, in a form approved by the City Attorney. The term of the agreement is for four months with a not-to-exceed contract amount of \$54,781; and authorize standard contingencies of 10% (\$5,478) and up to a 180-day term extension pursuant to the City's Purchasing and Contracting Guidelines, to be utilized if approved by the Public Works Director.

b. MAINTENANCE SERVICES AGREEMENT WITH MARIPOSA LANDSCAPES, INC. (MARIPOSA) FOR CITYWIDE LANDSCAPING OF PARKS AND MEDIANS AND RESOLUTION FOR BUDGET ADJUSTMENT

It was moved by VICE MAYOR HANSEN and seconded by COUNCIL MEMBER WOODS to authorize the Interim City Manager to enter into a Maintenance Services Agreement with Mariposa to provide citywide landscape maintenance services, in a form approved by the City Attorney. The term of the agreement is for one year with no more than three additional one-year extensions; authorize standard contingencies of 10% (\$40,394) and up to a 180-day term extension pursuant to the City's Purchasing and Contracting Guidelines, to be utilized if approved by the Public Works Director; and adopt Resolution No. 2022-09-6707.
