#### <u>Summary:</u>

Staff recommends the City Council consider entering into an MOU with City of Long Beach and a Public Works Contract with ILB Electric for construction of the East 20th Street and Redondo Avenue Intersection Improvement Project. This scope of work for this Project includes the following tasks:

- Installation of new traffic signal poles and foundations, signal mast arms, LED luminaire, signal heads, countdown pedestrian heads, pedestrian push buttons, pedestrian push button signs, pullboxes, PVC conduits (3"), and conductors;
- Installation of Type E and Type D inductive vehicle detector loops;
- Traffic striping and installation of internally illuminated street name sign; and
- Installation of grated line drain, and curb ramp per Caltrans Standard Plans D98H and A88A, Case C respectively.

#### Recommendations:

- 1. Authorize the City Manager to enter into an MOU with City of Long Beach for construction of the project, in a form approved by the City Attorney.
- 2. Authorize the City Manager to enter into a Public Works Contract with ILB Electric for construction of the Project, in a form approved by the City Attorney. The term of the agreement is for 90 working days upon issuance of

Notice to Proceed with a not-to-exceed contract amount of \$448,479.00.

- 3. Authorize contingencies of 10% (\$44,847.90) and up to a 180-day term extension pursuant to the City's Purchasing and Contracting Guidelines, to be utilized if approved by the Public Works Director.
- b. PUBLIC WORKS CONTRACT WITH PALP, INC. DBA EXCEL PAVING COMPANY (EXCEL PAVING) FOR OHIO AVENUE STREET REHABILITATION FROM HILL STREET TO SKYLINE AVENUE (PROJECT NO. 90.23003)

#### Summary:

The City Council will consider entering into a Public Works Contract with Excel Paving for construction of the Ohio Avenue Street Rehabilitation Project from Hill Street to Skyline Avenue (Project No. 90.23003). The Project includes:

- Approximately 26,000 square feet of asphalt pavement repair employing a combination of reconstruction and grind/overlay;
- Removal and replacement of approximately 560 square feet of damaged sidewalk;
- Restoration of traffic striping and markings; and
- Upgrade of two ADA access ramps.

#### Recommendations:

- 1. Authorize the City Manager to enter into a Public Works Contract with Excel Paving for construction of the Ohio Avenue Street Rehabilitation Project from Hill Street to Skyline Avenue (Project No. 90.23003), for a term of 40 calendar days and a not-to-exceed contract amount of \$294,491.40 in a form approved by the City Attorney.
- 2. Authorize a contingency of 10% (\$29,449) to accommodate additional scope of work and changed or unforeseen conditions to be utilized if approved by the Public Works Director for a total construction budget of \$323,940.40.

#### c. RESOLUTION APPROVING THE APPLICATION FOR CALIFORNIA ARTS COUNCIL (CAC) GRANT FOR THE SIGNAL HILL PARK AMPHITHEATER PROJECT

#### Summary:

With the passage of Assembly Bill 179 into law, the State approved funding for the City of Signal Hill in the amount of \$5,000,000 to construct a new outdoor amphitheater at Signal Hill Park. The California Arts Council (CAC) is the designated State entity responsible for allocation of the grant funds to the City and ensuring grant funds are used for the purposes specified. Prior to payment of grant funds, CAC requires submission of a grant application that includes information about the project and execution of a grant agreement. Adoption of this resolution provides City Council's approval of the grant application and authorizes the City Manager to execute all necessary documents to receive and expend the awarded grant funds.

#### Summary:

Staff recommends the City join the Gateway Cities Affordable Housing Trust (Housing Trust), a Joint Powers Authority (JPA) formed among the municipalities within the Gateway Cities region. The Housing Trust provides funding to preserve and produce affordable housing by increasing each project's competitiveness for state and federal funding. Additionally, the Housing Trust works with a variety of government and philanthropy groups to attract other housing funds. Joining the Housing Trust would support the City's efforts to build workforce developments identified in the Housing Element. To become a member, the City Council is required to adopt a resolution and authorize the Mayor to execute the Joint Exercise of Powers Agreement with the Housing Trust.

#### Fiscal Impact:

The construction budget for Project No. 90.20007 is \$541,649 as shown in Table 1, utilizing funds from traffic impact fees, Measure M, and Los Angeles County Metropolitan Transportation Authority (LACMTA). The overall project budget is \$627,714. Sufficient funds are available within the project budget.

#### Strategic Plan Objectives:

- Goal No. 4: Maintain and improve the public infrastructure.
- Goal No. 5: Ensure an enhanced quality of life for the residents.

#### Background:

Redondo Avenue and East 20<sup>th</sup> Street is a one-way stop sign controlled T-intersection within the limits of City of Long Beach. The intersection serves as a main gateway into the residential housing communities along East 20<sup>th</sup> Street in the City of Signal Hill and is approximately a quarter mile south of Browning High School. A signalized intersection was warranted by the City's Traffic Engineer to enhance pedestrian safety and vehicle circulation.

On February 22, 2017, the City's Traffic Engineering Consultant W.G. Zimmerman Engineering, Inc. (Zimmerman Engineering) observed existing and recorded traffic patterns during peak hours. Projected trip generations produced by the opening of Browning High School were also considered in the analysis, due to the anticipated additional pedestrian traffic crossing the East 20<sup>th</sup> Street and Redondo Avenue intersection because of the opening of the new high school. On March 7, 2017, Zimmerman Engineering provided the results of its traffic signal warrant analysis of the intersection. Based upon State and Federal criteria detailed in the California Manual on Uniform Traffic Control Devices, a traffic signal in this location is warranted due to the measured volume of vehicular traffic at peak hours. The analysis concluded that a traffic signal at this intersection would help regulate traffic flow at the intersection and provide adequate gaps for pedestrians to cross safely.

Over the past three years, the City Council has taken various actions to advance the development of

this project. On December 10, 2019, the City Council authorized an amendment to Zimmerman Engineering's on-call traffic engineering services contract with the City to include development of plans and specifications for a signalization project at the intersection of East 20<sup>th</sup> Street and Redondo Avenue. On February 22, 2022, the City Council authorized an agreement with LACMTA assigning the City's STP-L and HIP funds for use on this project. On June 28, 2022, the City Council adopted the FY 2022-23 Budget which included the East 20<sup>th</sup> Street and Redondo Avenue Intersection Improvement Project (Project No. 90.20007) as part of the Capital Improvement Program.

The proposed MOU between City of Signal Hill and City of Long Beach documents the mutual responsibilities of each agency. The City of Signal Hill would take responsibility for leading and funding the construction of the project. Upon completion of the construction phase, the City of Long Beach would take ownership and responsibility of the traffic signal, including any post-construction maintenance and operations. The public works staff and city attorneys of both agencies reviewed the MOU, which was subsequently submitted to the Long Beach for City Council approval on January 26, 2023. As of the time of this writing, the MOU is pending approval of Long Beach City Council.

Upon approval of the construction contract with ILB Electric, staff will direct ILB Electric to provide material submittals and authorize the purchase order of traffic signal poles and the controller. Signal poles and controllers are currently very long lead items in the industry, averaging 18 to 26 weeks for delivery after placement of the order. Mobilization and construction activities will be contingent on City of Long Beach's execution of the MOU and ILB Electric's acquisition of a right-of-way construction permit issued by City of Long Beach.

#### <u>Analysis:</u>

#### Bid Circulation Process

On February 16, 2023, the City posted a Notice Inviting Bids in accordance with Signal Hill Municipal Code at its public notice locations, sent the notice to subscribers through the City's website, and posted on PlanetBids via the City's portal.

#### Contractor Selection

ILB Electric, the lowest bidder, submitted all the required documents prior to the bid closing date and time, including its hard copy bid bond. All items and documents have been properly submitted; as such, staff determined ILB Electric to be the lowest responsive and responsible bidder. Staff conducted reference checks on the company's listed projects in the Statement of Qualifications and verified that ILB Electric, along with its subcontractors, are properly licensed to perform the work under this contract. Staff is recommending award of contract to ILB Electric in the amount of its bid.

Upon contract award, staff will execute contract documents and review submitted material documents. Upon approval of the submitted material documents, staff will issue authorization to the contractor to purchase the materials. The traffic signal poles and controller are long-lead items across the industry, with wait times averaging between 18 and 26 weeks. Therefore, Construction activities on the project are estimated to start in October 2023. Staff anticipates the project to be completed in April 2024.

#### MEMORANDUM OF UNDERSTANDING

THIS memorandum of understanding ("MOU" or "Agreement") is made and entered, \_\_\_\_\_\_on 2023, by and between the CITY OF LONG BEACH, a municipal corporation ("CLB") and the CITY OF SIGNAL HILL, a municipal corporation ("CSH").

WHEREAS, the CSH intends to construct a signalized intersection and associated improvements at East 20<sup>th</sup> Street and Redondo Avenue to enhance safety and improve mobility. The proposed improvement is located within CLB's Right of Way (ROW); and

WHEREAS, the improvements consists of installation of new traffic signal poles, signal cabinet, upgrade of access ramps, signage, stripping and replacement of existing curb gutter and sidewalk (the "Project"); and

WHEREAS, CSH will act as the lead and fully fund the design and construction phase of the Project. CLB will take ownership upon completion of the construction phase and concurrently assume responsibility for all and any post construction maintenance and operation services for the Project; and

WHEREAS, CSH anticipates advertising the Project for construction in February 2023.

NOW, THEREFORE, in consideration of the mutual terms and conditions in this Agreement, the parties agree as follows:

- 1. SCOPE OF WORK. The Project consists of the approved work identified in Plans number <u>E.R6362</u> and dated January 25<sup>th</sup>, 2022.
- 2. COSTS. The budget for the Project is estimated to be Five Hundred Forty Thousand Eight Hundred Dollars (\$540,800).
- 3. CSH'S RESPONSIBILITIES. CSH shall:
  - A. Act as the lead for the Project, including managing the construction schedule of performance.
  - B. Assume responsibility all construction and procurement activities for the Project, all undertaken in accordance with CSH's ordinances and policies, including the preparation of plans and specifications, cost estimates and all Project construction documents, utility identification and location, construction, engineering and management services, inspections, and financial accounting for Project activities.
  - C. Administer the contract for construction of the Project as required by applicable law.
  - D. Ensure Contractor's commercial general liability and business automobile liability insurance name CLB as additional insured and provide for waiver of subrogation and primary and non-contributory endorsements in favor of CLB.
  - E. Ensure CLB is indemnified under the construction contract with Contractor to the same extent as CSH is indemnified.

## 4. CLB'S RESPONSIBILITIES. CLB shall:

- A. CLB shall take full ownership and maintenance responsibilities of all traffic signal devices upon the completion of the Project and ensure continuous functionality of the improvements shown on Appendix A of this agreement.
- B. CLB shall be responsible for timely review and approval of changes to the project plans and specifications.
- C. CLB shall provide routine maintenance work on the traffic control device so that the said traffic control devises remain in good operating condition and repair. Routine maintenance work shall include, but is not limited to:
  - i. Inspect the signal system and clean the controller cabinets as applicable.
  - ii. Clean signal heads as reasonably required and no less than every three(3) years and replace light emitting diode (LED) as needed.
  - iii. Inspect the signal system and clean the controller cabinet as reasonably required and no less than every six (6) weeks.
  - iv. Clean signal heads as reasonably required and no less than every three(3) years and replace light emitting diode (LED) as needed.
  - v. Replacement of burned-out traffic signal lights (e.g. signal indications, pedestrian displays and/or illuminated street name signs).
  - vi. Annual inspection/testing of Conflict Monitor Units (CMU) and Malfunction Management Units (MMU).
  - vii. Inspection to assure video detection, loop detection and pedestrian detection systems are functional.
  - viii. Monthly inspection of battery backup power.
  - ix. Confirmation of controller timing to approved timing sheet.
  - x. Covering or removing any graffiti as reasonably required and no less than within forty-eight (48) hours of notification by any person or public agency.
- D. CLB shall ensure that any contractor's commercial general liability and business automobile liability insurance that performs such work for CLB name CSH as additional insured and provide for waiver of subrogation and primary and non-contributory endorsements in favor of CSH, and ensure that CSH is indemnified under the such contract to the same extent as CLB is indemnified.
- 5. MUTUAL AGREEMENTS.
  - A. CSH's Project plans signed by CLB shall constitute CLB's acceptance of and official approval of said plans.
  - B. The duties of CLB and CSH under this Agreement may be performed either by CLB or CSH employees or by persons or entities hired through separate agreements with CLB or CSH.

- C. If existing public and/or private utilities conflict with the construction of the Project, CSH and CLB will collaborate to identify such utilities. CSH and CLB will make all necessary arrangements with the owners of such utilities for their protection, relocation or removal.
- D. During the course of construction, CLB may request CHS to include additional work in the Project's scope, and the parties will negotiate in good faith to determine whether such additional work can and will be incorporated into the Project, provided such additional work does not exceed allotted Project funds.
- E. Following its completion but prior to acceptance of the Project, CSH will confer with CLB to obtain CLB's concurrence with the overall acceptance of Project in accordance with the approved plans and specifications.
- 6. WARRANTY. CSH will require the Contractor to convey a warranty for all materials and workmanship furnished in the construction of the Project for no less than one (1) year from the date of final completion of the Project. CSH shall manage and oversee CLB's warranty rights related to the Project and pursue and enforce the warranty for defects in workmanship or materials and require the construction contractor to repair or replace the defective work so that it complies with the plans and specifications for the Project.

## 7. INDEMNIFICATION.

- A. To the furthest extent permitted by California law, CLB shall defend, indemnify, and hold harmless CSH and CSH's agents, representatives, officers, consultants, employees, and volunteers (the "indemnified parties") from any and all demands, losses, liabilities, claims, suits, and actions (the "claims") of any kind, nature, and description, including, but not limited to, attorneys' fees and costs, to the extent directly or indirectly arising from personal or bodily injuries, death, property damage, or otherwise arising out of, connected with, or resulting from (1) the negligence, recklessness, or willful misconduct of CLB or CLB's agents, contractors, representatives, officers, consultants, employees, and volunteers, or (2) CLB's breach of this Agreement. CSH shall have the right to accept or reject any legal representation that CLB proposes to defend CSH.
- B. To the furthest extent permitted by California law, CSH shall defend, indemnify, and hold harmless CLB and CLB's agents, representatives, officers, consultants, employees, and volunteers (the "indemnified parties") from any and all demands, losses, liabilities, claims, suits, and actions (the "claims") of any kind, nature, and description, including, but not limited to, attorneys' fees and costs, to the extent directly or indirectly arising from personal or bodily injuries, death, property damage, or otherwise arising out of, connected with, or resulting from (1) the negligence, recklessness, or willful misconduct of CSH or CSH agents, contractors, representatives,

officers, consultants, employees, and volunteers, or (2) CSH's breach of this Agreement. CLB shall have the right to accept or reject any legal representation that CSH proposes to defend CLB.

## 8. NON-LIABILITY OF CITY OFFICERS AND EMPLOYEES.

- A. No officer or employee of the CSH shall be personally liable to the CLB in the event of any default or breach by the CSH or for breach of any obligation of the terms of this Agreement.
- B. No officer or employee of the CLB shall be personally liable to the CSH in the event of any default or breach by the CSH or for breach of any obligation of the terms of this Agreement.
- 9. NOTICE. Any notice hereunder by either party shall be in writing and personally delivered or deposited in the U.S. Postal Service, first class, postage prepaid, addressed to the City of Signal Hill at 2175 Cherry Avenue, Signal Hill, CA 90755, Attn: City Manager; and to the City of Long Beach at 411 West Ocean Boulevard, Long Beach, California 90802, Attn: City Manager. Notice shall be deemed given on the date that is one (1) day after being deposited in the mail or on the date personal delivery is made, whichever first occurs.
- 10. ENTIRE AGREEMENT. This Agreement constitutes the entire understanding between the parties and supersedes all other agreements, whether oral or written, with respect to the subject matter herein.
- 11. AMENDMENT. This Agreement shall not be amended except in writing signed by the parties that expressly refers to this Agreement.
- 12. TERMINATION. CSH may terminate this Agreement for convenience by giving thirty (30) days advance written notice to the CLB up until the completion of the construction of the Project without further liability to CLB. CLB may terminate this Agreement for convenience by giving thirty (30) days advance written notice to CSH up until completion of the construction of the Project, provided that in such event CLB shall reimburse CSH for all costs reasonably incurred by CLB under this Agreement through the date of termination.
- 13. SEVERABILITY. If any term, provision, covenant or condition of this Agreement is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remaining provisions of the Agreement shall continue in full force and effect, unless both parties would be materially affected by such interpretation.
- 14. GOVERNING LAW. This Agreement shall be governed by and construed in accordance with the laws of the State of California, with venue in any action in a court of competent jurisdiction located in Los Angeles County.

- 15. THIRD PARTY BENEFICIARY. This Agreement is not intended or designed to or entered for the purpose of creating any benefit or right for any person or entity of any kind that is not a party to this Agreement.
- 16. LEGAL ACTION. In addition to any other rights or remedies, either party may take legal action, in law or in equity, to cure, correct or remedy any default, to recover damages for any default, to compel specific performance of this Agreement, to obtain declaratory or injunctive relief, or to obtain any other remedy consistent with the purposes of this Agreement.
- 17. General Provisions. Any term herein can be waived only by a written waiver signed by the party against whom such waiver is to be asserted. This Agreement may be executed in one or more counterparts, each of which when so executed shall be deemed an original, and all of which, together, shall constitute one and the same instrument. Signatures transmitted electronically shall be deemed originals for all purposes of this Agreement.

IN WITNESS WHEREOF, the parties have caused this document to be duly executed with all formalities required by law as of the date first stated above.

#### CONTRACT

THIS CONTRACT is made this 28th day of March, 2023, in the County of Los Angeles, State of California, by and between the City of Signal Hill hereinafter called City, and International Line Builders, Inc. dba ILB Electric, hereinafter called Contractor. City and the Contractor for the considerations stated herein agree as follows:

**ARTICLE 1. SCOPE OF WORK.** The Contractor shall perform all Work within the time stipulated the contract and shall provide all labor, materials, equipment, tools, utility services, and transportation to complete all the Work required in strict compliance with the Contract Documents as specified in Article 5 below for the following Project:

#### E 20th Street and Redondo Avenue Intersection Improvement Project

The Contractor and its surety shall be liable to City for any damages arising as a result of the Contractor's failure to comply with this obligation.

**ARTICLE 2. TIME FOR COMPLETION.** The Work shall be commenced on the date stated in City's Notice to Proceed. The Contractor shall complete all Work required by the Contract Documents within 90 work days from the commencement date stated in the Notice to Proceed. By its signature hereunder, Contractor agrees the time for completion set forth above is adequate and reasonable to complete the Work.

**ARTICLE 3. CONTRACT PRICE.** City shall pay to the Contractor as full compensation for the performance of the Contract, subject to any additions or deductions as provided in the Contract Documents, and including all applicable taxes and costs, the sum of Four Hundred Forty Eight Thousand Four Hundred Seventy Nine Dollars (\$448,479.00). Payment shall be made as set forth in the General Conditions.

**ARTICLE 4. LIQUIDATED DAMAGES.** In accordance with Government Code section 53069.85, it is agreed that the Contractor will pay City the sum of \$1000 for each and every work day of delay beyond the time prescribed in the Contract Documents for finishing the Work, as Liquidated Damages and not as a penalty or forfeiture. In the event that Liquidated Damages are not paid, the Contractor agrees City may deduct that amount from any money due or that may become due the Contractor under the Contract. This Article does not affect the City's rights to other damages or remedies specified in the Contract Documents or allowed by law.

**ARTICLE 5. COMPONENT PARTS OF THE CONTRACT.** The "Contract Documents" include the following:

The Contactor shall complete the Work in strict accordance with all the Contract Documents.

All the Contract Documents are intended to be complementary. Work required by one of the Contract Documents and not by others shall be done as if required by all. This Contract shall supersede any prior agreement of the parties.

**ARTICLE 6. PROVISIONS REQUIRED BY LAW.** Each and every provision of law required to be included in these Contract Documents shall be deemed to be included in these Contract Documents. The Contractor shall comply with all requirements of applicable federal, state and local laws, rules and regulations, including, but not limited to, the provisions of the California Labor Code and California Public Contract Code which are applicable to this Project.

**ARTICLE 7. INDEMNIFICATION.** Contractor shall provide indemnification as set forth in the General Conditions.

**ARTICLE 8. PREVAILING WAGES.** Contractor shall be required to pay the prevailing rate of wages in accordance with the Labor Code which such rates shall be made available at City Hall or may be obtained online at http://www.dir.ca.gov/dlsr. and which must be posted at the job site.

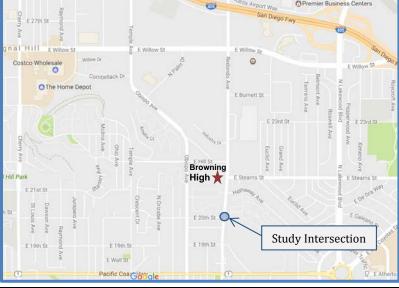
#### Subject: Redondo Avenue and East 20<sup>th</sup> Street Traffic Signal Warrant Analysis Memo

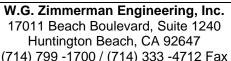
W.G. Zimmerman Engineering, Inc. has performed a traffic signal warrant analysis for the Redondo Avenue and East 20<sup>th</sup> Street intersection. Our results from this analysis are presented in this Letter Report. The traffic analysis was performed at the request of the City of Signal Hill to evaluate the need for a traffic signal at this intersection. The study was based upon the recent edition of the California Manual of Traffic Control Devices (CA-MUTCD), Chapter 4C – Traffic Signal Needs Studies. This section defines nine warrants which are based upon traffic conditions such as traffic volumes, traffic flow gaps, pedestrian characteristics, and physical conditions to determine whether a traffic signal is justified at this location. One or more of these traffic signal warrants (if applicable) must be satisfied to consider the installation of a traffic signal at the Redondo Avenue and East 20<sup>th</sup> Street intersection.

## **Project Description**

The Redondo Avenue and East 20<sup>th</sup> Street intersection is located in the City of Signal Hill. Figure 1 shows the project location map. The area south of East 20<sup>th</sup> Street consists of a combination of industrial and commercial developments. The area north of East 20<sup>th</sup> Street consists of residential developments, Browning High School and U.S. Army facilities.

## **Existing Conditions**

Redondo Avenue and East 20<sup>th</sup> Street is a one way STOP sign controlled T-intersection. Redondo Avenue is four lane arterial road oriented in the north-south direction. There is no parking allowed along Redondo Avenue near the intersection. East 20<sup>th</sup> Street is a two lane local street oriented in the east-west direction. There is no parking allowed along East 20<sup>th</sup> Street near the intersection.

## **Speed Survey**

The posted speed limit is 40 miles per hour along Redondo Avenue. The speed limit along East 20<sup>th</sup> Street is 25 miles per hour. A radar speed survey was conducted in September, 2016 to determine the vehicle travel speeds. Based upon the radar speed survey, the 85th-percentile vehicle speed on Redondo Avenue is 42 miles per hour in the northbound direction. The 85th-percentile vehicle speed on Redondo Avenue is 41 miles per hour in the southbound direction. The radar speed survey worksheet is included in Appendix A.

## **Existing Traffic Volumes**

Traffic and pedestrian counts at Redondo Avenue and East 20<sup>th</sup> Street intersection were conducted by Traffic Counts Unlimited in February, 2017. Vehicle and pedestrian count worksheets are included in Appendix B.

## **Future Traffic Volumes**

Future traffic volumes are based on a 1% per annum growth rate for traffic in the region in addition to approved development projects within the study area. The opening of Browning High School in the fall of 2017 will create additional trips within the project area. The year 2020 is used for future trip projections because fall 2020 will mark the first school year that all grade levels will have enrolled students.

## **Future Trip Generation**

The Institute of Transportation Engineers (ITE), "*Trip Generation*" *Report, 8th Edition*, was used to develop the traffic generated by the Browning High school site based on the type of land use. ITE code 530, "High School", was used to determine the number of peak period trips generated by the site. The ITE rates are based upon field studies of similar sized high schools and consider a typical level of bus and walking trips.

Table 1 summarizes the daily, morning, and afternoon peak hourly trips that the project could be expected to generate – based upon the ITE rates.

## Future Trip Distribution

Directional distribution percentages of the Browning High School trips were developed for the study intersection. These estimates, as shown in Table 2, are based upon assumptions involving the local geographical residency of the student population, roadway network pathways, and existing local travel patterns.

## **Future Trip Assignment**

The morning and afternoon Browning High School peak hour trips were assigned to the study intersection based upon the trip distribution assumptions. Table 2 illustrates the A.M. and P.M. peak hour trip assignments.

## Accident Data Analysis

Accident data has been obtained from the Statewide Integrated Traffic Records System (SWITRS) database for the City of Signal Hill from January 1, 2013 through December 31, 2015. This three (3) year data set has been sorted to refine the data for only accidents that occurred at the Redondo Avenue and East 20<sup>th</sup> Street intersection. In these three (3) years, there have been no reported accidents at the study intersection.

## **Traffic Signal Warrant Analysis**

The need for a traffic signal under fall 2020 conditions at the Redondo Avenue and East 20<sup>th</sup> Street Intersection has been reviewed with respect to the following CA-MUTCD warrants:

- Warrant 1, Eight-Hour Vehicular Volume
- Warrant 2, Four-Hour Vehicular Volume
- Warrant 3, Peak Hour
- Warrant 4, Pedestrian Volume
- Warrant 5, School Crossing

- Warrant 6, Coordinated Signal System
- Warrant 7, Crash Experience
- Warrant 8, Roadway Network
- Warrant 9, Intersection Near a Grade Crossing

Traffic signal Warrants 4 through 9 are not applicable to the Redondo Avenue and East 20<sup>th</sup> Street intersection.

The 85th-percentile speed on the study intersection's major street, Redondo Avenue, exceeds 40 miles per hour. In addition, there is only one outlet for the isolated community along East 20<sup>th</sup> Street which is provided by the Redondo Avenue and East 20<sup>th</sup> Street intersection. These qualifications warrant the 70 percent factor or "urban" classification to be utilized for the traffic signal warrant analysis. Based on the analysis, the criteria of traffic signal Warrants 1 and 3 are not met at the Redondo Avenue and East 20<sup>th</sup> Street. However the study intersection meets the traffic signal warrant under Warrant 2 criteria (see Appendix C).



## **Conclusions and Recommendations**

East 20<sup>th</sup> Street and Redondo Avenue serves as a main gateway to the residential housing communities along East 20<sup>th</sup> Street. The west leg of the study intersection is a conflict area between pedestrians crossing East 20<sup>th</sup> street and vehicles turning from Redondo Avenue onto East 20<sup>th</sup> Street. A significant number of the students who will attend Browning High live on the east and west sides of Redondo Avenue. The vehicle and pedestrian conflicts at the study intersection may be resolved through signal installation. A traffic signal at Redondo Avenue and East 20<sup>th</sup> will help regulate the traffic flow at the intersection and provide adequate gaps for pedestrians to cross safely. The installation of a traffic signal and upgrading the ADA ramps will directly impact this accident risk by providing a safe environment to safely cross East 20<sup>th</sup> Street. Utilizing a controlled intersection approach will provide visual information to students showing the how much time available to cross the street with the use of countdown pedestrian heads located on each leg of Redondo Avenue.

Based upon the State and Federal criteria detailed in the CA-MUTCD, traffic signal Warrant 2 is satisfied at the intersection of Redondo Avenue and East 20<sup>th</sup> Street, therefore it is recommended to install a traffic signal at this location.

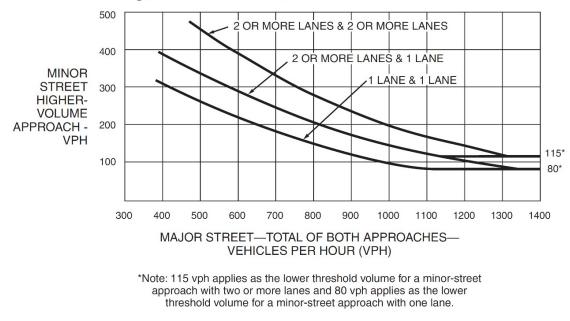

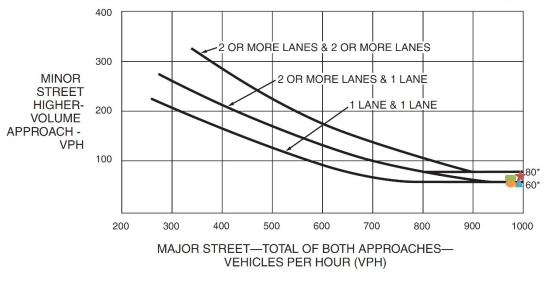


#### Figure 4C-1. Warrant 2, Four-Hour Vehicular Volume

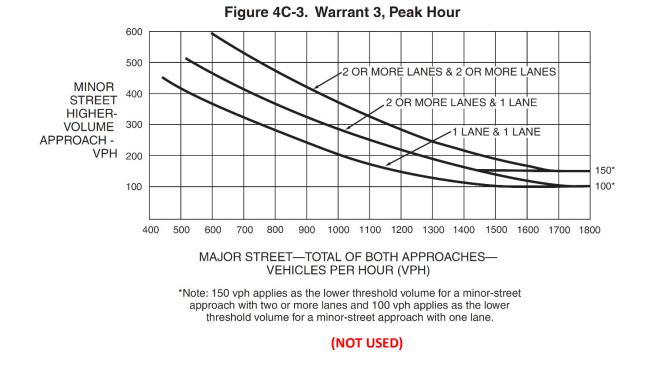


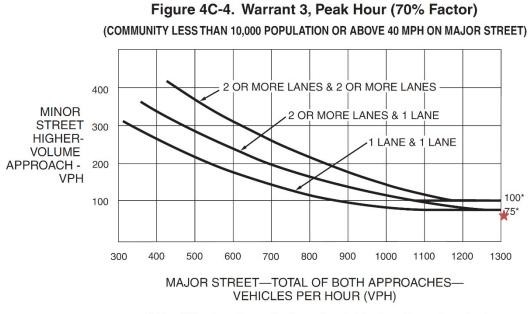
Figure 4C-2. Warrant 2, Four-Hour Vehicular Volume (70% Factor)

## PUBLIC WORKS CONTRACT WITH PALP, INC. DBA EXCEL PAVING COMPANY (EXCEL PAVING) FOR OHIO AVENUE STREET REHABILITATION FROM HILL STREET TO SKYLINE AVENUE (PROJECT NO. 90.23003)

#### <u>Summary:</u>

The City Council will consider entering into a Public Works Contract with Excel Paving for construction of the Ohio Avenue Street Rehabilitation Project from Hill Street to Skyline Avenue (Project No. 90.23003). The Project includes:

- Approximately 26,000 square feet of asphalt pavement repair employing a combination of reconstruction and grind/overlay;
- Removal and replacement of approximately 560 square feet of damaged sidewalk;
- Restoration of traffic striping and markings; and
- Upgrade of two ADA access ramps.

### Recommendations:

- 1. Authorize the City Manager to enter into a Public Works Contract with Excel Paving for construction of the Ohio Avenue Street Rehabilitation Project from Hill Street to Skyline Avenue (Project No. 90.23003), for a term of 40 calendar days and a not-to-exceed contract amount of \$294,491.40 in a form approved by the City Attorney.
- 2. Authorize a contingency of 10% (\$29,449) to accommodate additional scope of work and changed or unforeseen conditions to be utilized if approved by the Public Works Director for a total construction budget of \$323,940.40.

## Fiscal Impact:

The annual budget for the Fiscal Year (FY) 2022-23 Pavement Management Program is \$1,230,056. Actual costs and encumbrances to date total \$600,805, resulting in a remaining annual budget of \$629,251. Subtracting the total cost of this contract of \$294,491 and the \$29,449 contingency result in a remaining Pavement Management Program budget of \$305,311 (Table 1). At this time staff is proposing a carry-over of the remaining funds to FY 2023-24 to be utilized towards upcoming pavement projects in FY 2023-2024.

Funds are available as designated in the FY 2022-23 Capital Improvement Program Budget for Pavement Management, utilizing funding from Measure R (County), Measure M, Proposition C, and Road Maintenance and Rehabilitation Act (RMRA). Expenditures on this Project will be allocated toward Measure R and Proposition C to prioritize upcoming expenditure deadlines associated with these funding sources.

### Strategic Plan Objective:

Goal No. 4: Maintain and improve the public infrastructure.

### Background:

In February 2022, Bucknam Infrastructure Group, Inc. updated the Citywide Pavement Management Plan (PMP), which recommended maintenance and repair strategies to maintain and improve the overall Pavement Condition Index (PCI) of the City's streets. PCI is a measure of a street's pavement quality that ranges from 0 to 100, with a score of 100 representing a street that is in the best possible condition. The City Engineer reviewed the reviewed and approved the PMP and submitted it to Los Angeles County Metropolitan Transportation Authority in accordance with Proposition C local return guidelines. Staff presented the 2022 PMP to City Council on August 23, 2022.

Since the development of the updated PMP, the City has implemented two major pavement management projects, applying slurry seal to approximately one million square feet of City streets this year. Slurry seal is a cost-effective and minimally impactful maintenance approach intended to improve the PCI and extend the life of pavement that is already in relatively good condition. The City's CPI surveyed in 2021 was 73.7. As of March 2023, the estimated CPI is 78.2.

The subject Project is the third implementation of the Signal Hill PMP. Streets with PCIs lower than

46

60 typically require more costly repairs such as grind and overlay and/or deeper reconstruction. The PCI of Ohio Avenue from Hill Street to Skyline Avenue is 40 (very poor condition) as of the last assessment performed in 2022, therefore a combination of grind and overlay and deep-lift reconstruction is required to effectively restore the street to good condition. The scope of work for this Project includes approximately 26,000 square feet of asphalt pavement repair employing a combination of deep reconstruction and grind/overlay, approximately 560 square feet of sidewalk repair, reconstruction of two driveways, restoration of traffic striping and markings, and upgrade of two access ramps, on Ohio Avenue from Hill Street to Skyline Avenue.

## <u>Analysis:</u>

## Bid Circulation Process

On February 16, 2023, the Notice Inviting Bids was posted at the City's public notice locations, sent to subscribers through the City's website, and posted on PlanetBids via the City's portal.

### Contractor Selection

Excel Paving, the lowest bidder, submitted all required documents prior to the bid closing date and time, including its hard copy bid bond. All items and documents have been properly submitted; as such, staff determined Excel Paving to be the lowest responsive and responsible bidder.

Staff conducted reference checks on the company's listed projects in the Statement of Qualifications and verified that Excel Paving, along with its subcontractors, are properly licensed to perform the work under this contract. Staff is recommending award of contract to Excel Paving in the amount of their bid.

Upon contract award, staff will issue a Notice to Proceed and begin coordinating with the contractor. Construction of the project is estimated to start in April 2023; the project is anticipated to be completed in June 2023.

#### CONTRACT

THIS CONTRACT is made this 28<sup>th</sup> day of March, 2023, in the County of Orange, State of California, by and between the City of Signal Hill hereinafter called City, and PALP, Inc. DBA Excel Paving Company, hereinafter called Contractor. City and the Contractor for the considerations stated herein agree as follows:

**ARTICLE 1. SCOPE OF WORK.** The Contractor shall perform all Work within the time stipulated the contract and shall provide all labor, materials, equipment, tools, utility services, and transportation to complete all of the Work required in strict compliance with the Contract Documents as specified in Article 5 below for the following Project:

Ohio Avenue Street Rehabilitation Project

The Contractor and its surety shall be liable to City for any damages arising as a result of the Contractor's failure to comply with this obligation.

**ARTICLE 2. TIME FOR COMPLETION.** The Work shall be commenced on the date stated in City's Notice to Proceed. The Contractor shall complete all Work required by the Contract Documents within 40 calendar days from the commencement date stated in the Notice to Proceed. By its signature hereunder, Contractor agrees the time for completion set forth above is adequate and reasonable to complete the Work.

**ARTICLE 3. CONTRACT PRICE.** City shall pay to the Contractor as full compensation for the performance of the Contract, subject to any additions or deductions as provided in the Contract Documents, and including all applicable taxes and costs, the sum of Two Hundred Ninety Four Thousand Four Hundred Ninety One Dollars and Forty Cents (\$294,491.40). Payment shall be made as set forth in the General Conditions.

**ARTICLE 4. LIQUIDATED DAMAGES.** In accordance with Government Code section 53069.85, it is agreed that the Contractor will pay City the sum of \$500 for each and every calendar day of delay beyond the time prescribed in the Contract Documents for finishing the Work, as Liquidated Damages and not as a penalty or forfeiture. In the event that Liquidated Damages are not paid, the Contractor agrees City may deduct that amount from any money due or that may become due the Contractor under the Contract. This Article does not affect the City's rights to other damages or remedies specified in the Contract Documents or allowed by law.

**ARTICLE 5. COMPONENT PARTS OF THE CONTRACT.** The "Contract Documents" include the following:

All of the Contract Documents are intended to be complementary. Work required by one of the Contract Documents and not by others shall be done as if required by all. This Contract shall supersede any prior agreement of the parties.

**ARTICLE 6. PROVISIONS REQUIRED BY LAW.** Each and every provision of law required to be included in these Contract Documents shall be deemed to be included in these Contract Documents. The Contractor shall comply with all requirements of applicable federal, state and local laws, rules and regulations, including, but not limited to, the provisions of the California Labor Code and California Public Contract Code which are applicable to this Project.

#### Summary:

With the passage of Assembly Bill 179 into law, the State approved funding for the City of Signal Hill in the amount of \$5,000,000 to construct a new outdoor amphitheater at Signal Hill Park. The California Arts Council (CAC) is the designated State entity responsible for allocation of the grant funds to the City and ensuring grant funds are used for the purposes specified. Prior to payment of grant funds, CAC requires submission of a grant application that includes information about the project and execution of a grant agreement. Adoption of this resolution provides City Council's approval of the grant application and authorizes the City Manager to execute all necessary documents to receive and expend the awarded grant funds.

#### Recommendation:

Adopt a resolution, entitled:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, APPROVING THE APPLICATION FOR GRANT FUNDS FOR THE SIGNAL HILL PARK AMPHITHEATER PROJECT

#### Fiscal Impact:

The grant amount of \$5,000,000 will fund the design and construction of the Signal Hill Park Amphitheater Project. The initial receipt of funds will be recorded in the Capital Grants Fund (240).

#### Strategic Plan Objective:

Goal No. 4: Maintain and improve the public infrastructure.

## Background and Analysis:

On September 6, 2022, Governor Gavin Newsom signed Assembly Bill 179 which approved \$5,000,000 to be allocated by the CAC to the City for the Signal Hill Park outdoor amphitheater. Staff worked with Senator Lena A. Gonzalez's office for procurement of the grant and submission of applicable documents. According to Section 19.56 of the Budget Act of 2022, funds shall be available for encumbrance through June 30, 2024, and expenditure until June 30, 2026. The designated State entity (CAC) shall allocate funds to the recipient (Signal Hill) and shall determine the best method for allocation to ensure funds are used for the purposes specified. Consistent with this provision, the CAC requested on February 28, 2023, that the City submit a grant application by March 31, 2023, to include information about the project and a resolution from City Council approving the application for grant funds. Upon disbursement of the grant funds, the State may continue to perform audits, as frequently as annually, and for three years following payment of the grant funds.

After execution of the grant agreement with CAC, and upon receipt of payment of the grant amount, staff will proceed with the initial planning of the amphitheater and integration with an overall Signal Hill Park plan, community outreach, environmental review, and engineering design phases of the project. Staff will coordinate the City's project with the CAC to ensure the project remains eligible for funding throughout the design and construction process.

#### Summary:

Staff recommends the City join the Gateway Cities Affordable Housing Trust (Housing Trust), a Joint Powers Authority (JPA) formed among the municipalities within the Gateway Cities region. The Housing Trust provides funding to preserve and produce affordable housing by increasing each project's competitiveness for state and federal funding. Additionally, the Housing Trust works with a variety of government and philanthropy groups to attract other housing funds. Joining the Housing Trust would support the City's efforts to build workforce developments identified in the Housing Element. To become a member, the City Council is required to adopt a resolution and authorize the Mayor to execute the Joint Exercise of Powers Agreement with the Housing Trust.

### Recommendations:

1. Adopt a resolution, entitled:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, APPROVING, AUTHORIZING, AND DIRECTING CITY EXECUTION OF THE JOINT EXERCISE OF POWERS AGREEMENT RELATING TO MEMBERSHIP IN THE GATEWAY CITIES AFFORDABLE HOUSING TRUST

2. Authorize the Mayor to execute the Gateway Cities Affordable Housing Trust Joint Exercise of Powers Agreement.

### Fiscal Impact:

The City is required to fund a pro-rata share of the annual administrative costs of the Housing Trust starting July 1, 2024. The estimated annual administrative expenses for the first year of operations for the Housing Trust are \$7,500, with a projected annual increase based on the Consumer Price Index for the Los Angeles-Long Beach-Anaheim area. The City Council would have the opportunity to consider this ongoing expenditure as part of the budget adoption process. Staff proposes utilizing funding from the Housing Authority for these projected costs.

## Strategic Plan Objectives:

- Goal No. 1: Ensure long-term fiscal stability.
- Goal No. 5: Ensure an enhanced quality of life for residents.
- Goal No. 6: Promote a transparent and open government.

## Background and Analysis:

The purpose of the Housing Trust is to help cities address their Regional Housing Needs Assessment (RHNA) which is mandated by State Housing Law as part of the periodic process of updating local housing elements of the General Plan for each city. RHNA quantifies the need for housing within each jurisdiction during an eight year planning period. The City's certified Housing Element allows for the development of up to 380 workforce housing units. The development costs associated with site acquisition, remediation, and construction of any residential development are significant. In the specific case of workforce housing, rents generated by these developments are below market-rate which results in reduced cash flow and creates a funding gap. Additional funding including tax credits, low-interest loans, and other sources are necessary to ensure workforce housing projects are financially feasible. The purpose of a Housing Trust is to improve the success rate of securing additional funding for a specific region; thereby increasing development of these units.

## Housing Trust Development Process

In the past eight-year planning period, from 2013 through 2021, the Gateway Cities Council of Governments (COG) subregion received tax credit funding for 58 projects totaling nearly 6,000 housing units. The Gateway Cities COG reports there are approximately 38 affordable housing projects currently in the pipeline that have not yet started construction. Most of these projects require a gap funding subsidy funding to start construction. Such projects, including the two proposed workforce housing projects in the City's adopted Housing Element, would benefit from additional funding provided by the Housing Trust.

The Gateway Cities region of Los Angeles County includes 27 cities located along the I-710 corridor in eastern Los Angeles County. Early in 2021, the Gateway Cities COG obtained State funding from the Southern California Association of Governments (SCAG) to explore the formation of an affordable housing trust within the region. As noted, the Housing Trust provides funding to preserve and produce affordable housing. Funds provided as a result of the Housing Trust improve the financial viability of individual housing projects and programs.

The Gateway Cities COG and its consultant engaged in a number of activities to understand the needs of the region, create a sustainable framework for the Housing Trust, and develop an actionable program. The process included interviewing Gateway Cities COG cities, housing developers, and

financing entities to determine housing needs and priorities, explain the concept of the Housing Trust, and investigate general interest in being a member. The Gateway Cities COG also researched best practices from other local housing trusts and prepared a comparative review of organizational and governance structures.

The formation process also include a Steering Committee of Gateway Cities COG City Managers and others to work with the Gateway Cities COG and the consultants to make the initial recommendations regarding how a Housing Trust might be formed and explore the initial sources of funding to support this effort. Based on its research and dialogue with the Housing Trust Steering Committee, the Gateway Cities COG advanced negotiations of a Joint Exercise of Powers Agreement, developed an Administrative Plan, identified Governance Structure, and prepared bylaws for the Housing Trust.

The Gateway Cities COG is currently working on a strategic plan for the Housing Trust which will be presented for review by the Gateway Cities COG Board and final adoption by the new Board of Directors of the Housing Trust Board when it is in place. The Housing Trust will also develop an operating plan, including a capital and administrative budget for its first year operations which is expected to begin July 1, 2023.

## Membership Structure

As outlined in the Joint Exercise of Powers Agreement, the Housing Trust does not build, own, or manage housing projects. The Housing Trust cannot require that housing projects be located in specific cities, require member cities to take an allocation of supportive housing units, or require that cities provide a local funding match. The Housing Trust Board of Directors determines whether a funding application meets the Notice of Funding Availability (NOFA) criteria. Each local jurisdiction maintains land use control and processes the entitlement consistent within its zoning, municipal code requirements, and development standards.

The Joint Exercise of Powers Agreement contains a provision that requires members to contribute towards annual administrative expenses. Member cities are not required to contribute funding until July 1, 2024. Prior to this period, the Gateway Cities COG secured administrative formation funding for the Housing Trust. The administrative expenses are based upon city population as shown below:

- Up to 30,000 = \$7,500
- 30,001 to 60,000 = \$15,000
- 60,001 to 100,000 = \$32,500
- Greater than 100,000 = \$47,500

Based on the population distribution above, the pro-rata share of the City's administrative expenses is \$7,500. This amount is expected to increase annually in an amount equal to the U.S. Bureau of Labor Statistics Consumer Price Index for the Los Angeles-Long Beach-Anaheim area. The adjustment is calculated based on the 12-month period preceding the year the fees are assessed. The City would maintain the right to withdraw from the JPA subject to an approved resolution and by providing a six-month notice.

### Governance Structure

As noted, the Housing Trust will be a public government entity established by joint powers authority and in accordance with the Joint Exercise of Powers Act, as codified by the California Government Code. The Housing Trust will be organized to receive public and private capital and administrative funds to address local housing needs. The Housing Trust is governed by a nine-member Board of Directors. Pursuant to the JPA bylaws the Board is comprised of seven elected officials whose governing body is a member of Housing Trust and appointed by the Gateway Cities COG Board. A Housing Trust member city will be represented on the Board by each population category specified in the Housing Trust Membership fee calculation. Two additional Board members are experts in homelessness or housing policy and approved by the Gateway Cities COG City Managers Committee.

## **Recommended Action**

In summary, joining the Housing Trust would support the City's Housing Element goals of encouraging workforce housing. Joining the Housing Trust would also enable the Gateway cities region to be more competitive for state and federal funding. To become a member, the City Council would adopt a resolution (Attachment A) and authorize the Mayor to execute the Joint Exercise of Powers Agreement with the Housing Trust (Attachment B). Staff has also attached the Housing Trust bylaws for the City Council's information (Attachment C).

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, APPROVING, AUTHORIZING, AND DIRECTING CITY EXECUTION OF THE JOINT EXERCISE OF POWERS AGREEMENT RELATING TO MEMBERSHIP IN THE GATEWAY CITIES AFFORDABLE HOUSING TRUST

**WHEREAS**, The Gateway Cities Affordable Housing Trust (GCAHT) will be formed upon the approval of at least three qualified members as a joint powers authority between cities throughout the Gateway Cities subregion; and

WHEREAS, GCAHT was created for the purpose of funding housing specifically assisting persons and families of extremely low, very low, low and moderate income within the County of Los Angeles; and

WHEREAS, the City of Signal Hill (the "City") determined through its 6<sup>th</sup> Cycle Housing Element Update that there is great need for more affordable housing in the City; and

WHEREAS, the City determined that there are limited financial resources for affordable housing development and that additional local financing increases the competitiveness of individual projects for the State and Federal resources; and

WHEREAS, the City determined that it is in the public interest and for the public benefit that the City become a member of the GCAHT to further facilitate the development of affordable housing in the City and throughout the region, including the financing of projects therefore by the GCAHT; and

WHEREAS, the City will be joining other cities that are members of the GCAHT in efforts to increase State and Federal resources for affordable housing directed to GCAHT; and

WHEREAS, the Agreement has been filed with the City, and the members of the City Council of the City (the "City Council"), with the assistance of its staff, have reviewed said document; and

WHEREAS, the GCAHT is authorized to issue grants and loans to developers for the purpose, among others, of financing or refinancing the construction, acquisition and rehabilitation of affordable housing; and

WHEREAS, the City anticipates there will be affordable housing projects in need of financing located in the City of Signal Hill.

## NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SIGNAL HILL, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

<u>Section 1.</u> The foregoing recitals are true and correct.

<u>Section 2.</u> The City Council hereby authorizes the City's membership in the Gateway Cities Affordable Housing Trust (GCAHT).

<u>Section 3.</u> The City Council reviewed and approves of the Joint Exercise of Powers Agreement substantially in the form attached (Exhibit A).

Section 4. The adoption of this Resolution shall not obligate the City or any department thereof to (i) provide any financing to acquire, construct or operate any Project or any refinancing of any Project; (ii) approve any application or request for or take any other action in connection with any planning approval, permit or other action necessary for the acquisition, improvement, rehabilitation or operation of any Project; (iii) require any contribution or advance any funds whatsoever to the GCAHT other than membership fees for administrative costs; or (iv) except as provided in this Resolution, take any further action with respect to the GCAHT or its membership therein.

Section 5. The Mayor, the City Clerk and all other proper officers and officials of the City are hereby authorized and directed to execute the Joint Exercise of Powers Agreement and to perform such other acts and deeds, as may be necessary or convenient to affect the purposes of this Resolution and the transactions herein authorized.

<u>Section 6.</u> The City Clerk shall forward a certified copy of this Resolution and an originally executed Agreement to the GCAHT:

## JOINT EXERCISE OF POWERS AGREEMENT

THIS JOINT EXERCISE OF POWERS AGREEMENT (this "Agreement") is made this 28<sup>th</sup> day of March 2023 (the "Effective Date"), by and between the following public entities (each a "Party" and, collectively, the "Parties"): City of Artesia, City of Paramount, City of Lakewood, and City of Signal Hill.

## RECITALS

- A. The Parties have a strong interest in promoting the health, safety, and welfare of the residents within their geographic boundaries.
- B. Each Party has the individual power to implement affordable housing projects and programs generated within its jurisdictional boundaries, as well as, to create and issue development agreements for such activities.
- C. The Parties find it in their mutual interest to address affordable housing issues on a regional level.
- D. An adequate supply of housing throughout the Gateway Cities subregion will provide social and economic benefits to residents and taxpayers of the Parties.
- E. The Parties desire to act in the public interest to lessen the burden of government by reducing the need for each Party to act individually, and to provide charitable support for affordable housing in the Gateway Cities subregion of Los Angeles County (the "County").
- F. California Government Code section 6500 *et seq*. ("Joint Exercise of Powers Act" or "Act") permits two or more public agencies to create joint powers authorities for the purposes cited herein and permits the agencies to exercise jointly any power that the public agencies could exercise separately, and further grants certain additional powers to such joint powers authorities.
- G. Local land-use decisions remain solely with each Party. Nothing in this Agreement deprives any Party of its sovereign powers with respect to land-use or transfers such powers to the joint powers authority.

NOW, THEREFORE, in consideration of the mutual promises set forth below, the Parties agree as follows:

## Section 1. Creation and Purpose.

(a) <u>Creation of GCAHT.</u> Pursuant to the Joint Exercise of Powers Act, there is hereby created a public entity to be known as the "Gateway Cities Affordable Housing Trust" ("GCAHT"). GCAHT shall be a public entity separate and apart from the Parties and shall administer this Agreement. (b) <u>Purpose</u>. This Agreement is made pursuant to the Joint Exercise of Powers Act for the purpose of creating the GCAHT as a public entity separate from the Parties to: (i) exercise common powers with respect to receiving public and private financing and funds; and (ii) fund the planning and construction of housing of all types and tenures for persons and families of extremely low-, very low-, low- and moderate-income, as defined in Section 50093 of the Health and Safety Code, including, but not limited to, permanent supportive housing. The purpose of this Agreement shall be accomplished, and common powers exercised in the manner set forth in this Agreement. Nothing contained in this Agreement shall preclude the Parties form establishing, maintaining, or providing social programs or services to its residents as each deems proper and necessary.

## Section 2. Term and Termination.

- (a) <u>Term</u>. This Agreement shall become effective, and GCAHT shall come into existence, on the Effective Date, and this Agreement shall thereafter continue in full force and effect until terminated pursuant to subdivision (b) of this section.
- (b) <u>Termination</u>. This Agreement may be terminated by agreement of the Parties. Upon termination of this Agreement, GCAHT shall be dissolved and, after payment of or provision for payment of all liabilities, the assets of GCAHT shall be distributed to the Parties in proportion to the contribution of each Party to GCAHT and the amounts paid by each Party in connection with GCAHT's activities.

## Section 3. Powers and Duties of GCAHT.

- (a) <u>General Powers.</u> GCAHT shall have all the powers common to the Parties to this Agreement necessary or convenient, specified, or implied, to accomplish the purpose of this Agreement as set forth in Section 1, subject to the restrictions set forth in Section 3, subdivision (c) below. Said powers shall be exercised in the manner provided in the Joint Exercise of Powers Act and, except as expressly set forth herein, subject only to such restrictions upon the manner of exercising such powers as are imposed upon the Parties in the exercise of similar powers.
- (b) <u>Specific Powers.</u> Without limiting the generality of the powers conferred in subdivision (a) of this Section 3, GCAHT is hereby authorized, in its own name, to do all of the acts necessary or convenient to the accomplishment of the purposes of this Agreement and the full exercise of the powers conferred in subdivision (a) of this Section 3, including but not limited to the following:
  - 1. to make and enter into contracts;
  - 2. to contract for staff assistance;
  - 3. to sue and be sued in its own name;
  - 4. to apply for, accept, receive and disburse grants, loans and other aids from any agency of the United States of America, the State of California, Los Angeles County, Party to

this Agreement, or any other agency providing funding related to the purposes of this Agreement;

- 5. to invest any money in the treasury pursuant to Section 6505.5 of the Joint Exercise of Powers Act that is not required for the immediate necessities of GCAHT, as GCAHT determines is advisable, in the same manner and upon the same conditions as local agencies, pursuant to Section 53601 of the California Government Code;
- 6. to apply for letters of credit or other forms of financial guarantees in order to enter into agreements in connection therewith;
- 7. to carry out all the provisions of this Agreement;
- 8. to purchase obligations of any Party;
- 9. to engage the services of private consultants to render professional and technical assistance and advice in carrying out the purposes of this Agreement;
- 10. to employ and compensate legal counsel determined appropriate by GCAHT in accomplishment of the purposes of this Agreement;
- 11. to contract for engineering, construction, architectural, accounting, environmental, land use, or other services determined necessary or convenient by GCAHT in connection with the accomplishment of the purposes of this Agreement;
- 12. for the purposes of enforcing affordable housing covenants or holding security interests for loans, to take title to, and transfer, sell by installment sale or otherwise, lands, structures, real or personal property, rights, rights-of-way, franchises, easements, and other interests in real or personal property which GCAHT determines are necessary or convenient in connection with the accomplishment of the purposes of this Agreement;
- 13. for the purposes of renting space for GCAHT to operate, to lease to, and to lease from, a Party or any other person or entity, lands, structures, real or personal property, rights, rights-of-way, franchises, easements, and other interests in real or personal property which GCAHT determines are necessary or convenient in connection with the accomplishment of the purposes of this Agreement;
- 14. to solicit charitable contributions from private sources;
- 15. to propose amendments to this Agreement; and
- 16. to exercise any and all other powers as may be provided for GCAHT in the Joint Exercise of Powers Act or any other applicable law.
- (c) Limitation on Powers. This Agreement does not authorize GCAHT do any of the following:
  - 1. Regulate land use in cities or in the unincorporated area of the County;
  - 2. Serve as an owner or operator of housing units;

- 3. Levy, or advocate or incentivize the levying of, an exaction, including an impact fee, charge, dedication, reservation or tax assessment, as a condition of approval of a development project;
- 4. Require or incentivize inclusionary zoning requirements;
- 5. Require the Parties to dedicate or assign funding for any GCAHT obligations or programs;
- 6. Approve a housing project or program that is not supported by the governing body of the jurisdiction (a city or the county) in which the proposed project is sited; or
- 7. Require the Parties to accept or provide any member of housing units as a prerequisite to joining or remaining a member of GCAHT.

## Section 4. Members.

The members of GCAHT shall be the Parties who have not withdrawn from GCAHT, and such other Parties as may join GCAHT after execution of this Agreement. New members may join on the terms and conditions set forth in Section 10 hereof. Only cities within the County of Los Angeles and within the Gateway Cities subregion may be a party to this Agreement and a member of GCAHT.

## Section 5. Board of Directors.

- (a) <u>Selection of Directors.</u> GCAHT shall be governed by a Board of Directors consisting of nine Directors selected as follows:
  - 1. Seven Directors who are members of the Gateway Cities Council of Governments ("GCCOG") Governing Board ("GCCOG Board"), or any elected official serving within the GCCOG jurisdiction that is also a Party and appointed by the GCCOG Board.
  - 2. Two Directors that are experts in homelessness or housing policy appointed by the Gateway Cities Council of Governments City Managers Committee.
  - 3. Alternates for each Director position may be established by the appointing entity.
- (b) <u>Board Powers.</u> Subject to the limitations of this Agreement and the laws of the State of California, the powers of GCAHT shall be vested in and exercised by, and its property and its affairs administered by, the Board of Directors.
- (c) <u>Advisory Board.</u> The Board of Directors may appoint advisory boards that may include such persons as designated by the Board of Directors. The Board of Directors shall adopt bylaws that govern the appointment of advisory boards should it determine in its discretion to appoint such advisory boards.
- (d) <u>Compensation</u>. Members of the Board shall serve without compensation but shall be entitled to reimbursement for any expenses actually incurred in connection with serving as Director; provided such expenses have been previously approved by the Board of

Directors and incurred in accordance with any GCAHT policies or procedures governing the same.

- (e) <u>Term.</u> Members of the Board shall serve for a two-year term. There are no term limits. The initial Board will serve a term staggered between one-year and two-year terms. Three of the seven Directors who are members of the GCCOG Board or are appointed by the GCCOG Board in accordance with Section 5(a) shall have an initial term of one year. One of the two Directors that are experts in homelessness or housing policy shall have an initial term of one year. The initial one-year terms will be determined through the drawing of lots.
- (f) Meetings of the Board of Directors.
  - 1. <u>Call, Notice and Conduct of Meetings.</u> All meetings of the Board of Directors, including without limitation, regular, adjourned regular, special meetings and adjourned special meetings, shall be called, noticed, held and conducted in accordance with the provisions of the Ralph M. Brown Act, Government Code section 54950 *et seq.*
  - 2. <u>Regular Meetings.</u> Regular meetings of the Board of Directors shall be held at such dates and times as the Board may fix by resolution from time to time. If any day so fixed for a regular meeting shall fall upon a legal holiday, then such regular meeting shall be held on the next succeeding business day at the same hour. No notice of any regular meeting of the Board of Directors need be given to the individual Directors.
  - 3. <u>Special Meetings</u>. Special meetings of the Board of Directors shall be held whenever called by the Chairperson of the Board or by a majority of the Directors. Notices of all special meetings shall be provided to all Parties.
  - 4. <u>Quorum.</u> A majority of the seated members of the Board of Directors shall constitute a quorum at any meeting of the Board except that less than a quorum may adjourn a meeting to another time and place. Every act or decision done or made by a majority of the Directors present at any meeting at which a quorum is present shall be the act of the Board of Directors.
  - 5. <u>Minutes.</u> The Board of Directors shall keep minutes of all regular, adjourned regular, and special meetings, and shall, as soon as possible after each meeting, cause a copy of the minutes to be forwarded to each Director and to the Parties.
  - 6. <u>Officers.</u> The Board of Directors shall elect a chairperson and a vice chairperson from among its Directors at the first meeting held in each fiscal year. In the event that the chairperson or vice chairperson so elected ceases to be a Director, the resulting vacancy shall be filled at the next regular meeting of the Board of Directors held after such vacancy occurs or at a special meeting called for that purpose. In the absence or inability of the chairperson to act, the vice chairperson shall act as chairperson. The chairperson, or the chairperson's absence, the vice chairperson, shall preside at and conduct all Board of Director's meetings.

7. <u>Rules and Regulations</u>. The Board of Directors may adopt, from time to time, by resolution, such rules, regulations, and bylaws for the conduct of its meetings and affairs as the Board determines is necessary or convenient.

## Section 6. Additional Officers and Employees.

- (a) Officers and Contract Staff.
  - 1. GCAHT may contract with a Party or the GCCOG, for officers and staff pursuant to Section 6(d), or retain independent contractors, agents, or volunteers as the Board of Directors may deem necessary to carry out any of GCAHT's powers, upon such terms and conditions as the Board may require, including the retaining of professional and technical assistance, provided that adequate funds are available in GCAHT's budget and are appropriated by GCAHT therefor.
  - 2. None of the officers, agents, or staff, if any, directly contracted by GCAHT shall be deemed, by reason of their roles or duties or contracted status, to be employed by the Parties.
- (b) <u>Treasurer and Auditor/Controller.</u> Pursuant to Government Code Sections 6505.5 and 6505.6, the Board of Directors shall appoint an officer or employee of GCAHT, or an officer or employee of a public agency that is a Party, or a certified public accountant to hold the offices of treasurer and auditor for GCAHT. Such person or persons shall possess the powers of and shall perform the treasurer and auditor functions for GCAHT required by Sections 6505, 6505.5 and 6505.6 of the Government Code, including any subsequent amendments thereto. Pursuant to Government Code Section 6505.1, the auditor and treasurer shall have charge of certain property of GCAHT. The treasurer and auditor shall assure that there shall be strict accountability of all funds and reporting all receipts and disbursements of GCAHT. The treasurer and auditor of Directors in an amount, which shall be established by the Board. Should the existing bond or bonds or any such officer be extended to cover the obligations provided herein, said bond shall be the official bond required herein. The premiums on any such bonds attributable to the coverage required herein shall be an appropriate expense of GCAHT.
- (c) <u>Attorney.</u> The Board of Directors shall have the power to appoint one or more legal advisors to GCAHT who shall perform such duties as may be prescribed by the Board.

## (d) Administrative Services and Reimbursement of Costs.

 The Board of Directors may contract with a Party to provide necessary administrative services to GCAHT, including the services described in Section 6(a), (b) and (c). The amount charged by the Party to provide such services to GCAHT shall be fixed by agreement between the Board of Directors and the governing board of the Party providing such services. In the absence of an agreement on costs, the Party providing services to GCAHT under this Section 6 may charge GCAHT the amounts necessary to recover the direct and indirect costs of such services.

2. If GCAHT contracts with a Party to provide GCAHT with administrative services through persons who are employees and officers of the Party, then any retirement liabilities associated with that Party's employees and officers shall not constitute a liability of GCAHT or any other Party. This Section 6(d)(2), shall not preclude a Party providing administrative services to GCAHT pursuant to a contract with GCAHT from accounting for such salary and benefit costs when negotiating the rates that the Party will charge GCAHT for providing such services.

## Section 7. Financial Provisions.

- (a) <u>Fiscal Year</u>. The Fiscal Year of GCAHT shall, unless and until changed by the Board of Directors, commence on the 1<sup>st</sup> day of July of each year and shall end on the 30<sup>th</sup> day of June of the next succeeding year except that the initial Fiscal Year of GCAHT shall commence on the Effective Date and end on the immediately following 30<sup>th</sup> day of June.
- (b) Budget.
  - 1. <u>General Budget.</u> Within one hundred and twenty days (120) after the first meeting of the Board of Directors, a general budget for the first fiscal year shall be adopted by the vote of a majority of all the Directors. The budget shall distinguish between administrative costs (i.e., the cost of operating GCAHT) and Program costs (i.e., the financing of the programs funded or sponsored by GCAHT). Thereafter, at or prior to the last meeting of the Board of Directors for each fiscal year, a general budget shall be adopted for the ensuing fiscal year or years by a vote of at least a majority of all Directors of the Board.
  - 2. <u>Expenditures for the Approved Budget</u>. The payment of all GCAHT obligations is limited to the amount of appropriations allowed in GCAHT's approved budget, except as it may be revised with the approval of a majority of all of the Directors of the Board of Directors.
- (c) <u>Contributions by the Parties.</u>
  - <u>Administrative Cost Contributions.</u> The GCCOG shall be responsible for GCAHT's administrative costs until June 30, 2024. After this initial period, and in consideration of the mutual promises contained herein, the Parties agree that they shall make annual contributions (each a "Fee" and collectively the "Fees") towards the budgeted administrative costs of GCAHT in accordance with a cost allocation formula as outlined below:

POPULATION	ANNUAL ADMINISTRATIVE FEE
Up to 30,000	\$7,500
30,001 - 60,000	\$15,000

60,001 - 100,000	\$32,500
>100,000	\$47,500

The Fees shall be assessed annually. After the first fiscal year, the Fees shall increase annually in an amount equal to the U.S. Bureau of Labor Statistics consumer price index for all urban consumers in the Los Angeles-Long Beach-Anaheim area for the 12-month period preceding the year the Fees are assessed. Payment of the Fees shall be due within 30 days of receipt of an invoice from the GCAHT. The invoice shall indicate how the Fees were calculated. A Party's contribution to GCAHT's administrative costs shall be in the form of money, unless the Board of Directors approves another form of contribution such as services, personal property or use of real or personal property, or other in-kind contributions. The acceptance and valuation of any such non-monetary contributions may be used to offset in whole or part a Party's contribution as determined in the sole and absolute discretion of the Board of Directors. Notwithstanding the above, after the first fiscal year the Board of Directors may establish Fees in an amount the Board of Directors deems financially prudent; provided it shall roughly be proportional as to each Party in the amounts reflected in the table above.

- 2. <u>Program Cost Contribution.</u> The particular programs and program budget, funded, sponsored or operated by GCAHT, as well as the level of, and mechanisms for, the involvement of GCAHT and each Party, in such programs and program budget, shall be determined and approved by the Board of Directors.
- (d) Accounts and Reports.
  - 1. <u>Books and Records.</u> There shall be strict accountability of all GCAHT funds and accounts and report of all GCAHT receipts and disbursements. Without limiting the generality of the foregoing, GCAHT shall establish and maintain such funds and accounts as may be required by good accounting practice. The books and records of GCAHT shall be open to inspection at all reasonable times by each Party and its duly authorized representatives.
  - <u>Annual Audit.</u> The person appointed by the Board of Directors to perform the auditor function for GCAHT shall cause an annual independent audit of the accounts and records of GCAHT and records to be made by a certified public accountant or firm of certified public accountants in accordance with Government Code section 6505. Such audits shall be delivered to each Party and shall be made available to the public.
  - 3. <u>Annual Financial Report.</u> GCAHT shall publish an Annual Financial Report that shall describe the funds received by GCAHT and the use of such funds by GCAHT. The Annual Financial Report shall describe how the funds received by GCAHT have furthered the purposed of GCAHT.

(e) <u>Funds.</u> Subject to the applicable provisions of any instrument or agreement which GCAHT may enter into, which may provide for a trustee or other fiscal agent to receive, have custody of and disburse GCAHT funds, the person appointed by the Board of Directors to perform the treasurer function for GCAHT shall receive, have the custody of and disburse GCAHT funds as nearly as possible in accordance with generally accepted accounting principles, shall make the disbursements required by this Agreement or to carry out any of the provisions or purposes of this Agreement.

#### Section 8. Amendments and Additional Parties.

- (a) This Agreement may not be amended or modified except by a vote of two-thirds of all the Parties through formal action approving such an amendment by the Parties' respective governing bodies.
- (b) No addition to, or alteration of, the terms of this Agreement, whether by written or oral understanding of the parties, their officers, employees or agents, shall be valid or effective unless made in the form of a written amendment which is formally adopted and executed by the Parties in the same manner as this Agreement.

#### Section 9. Non-Liability for Obligations of GCAHT.

- (a) The debts, liabilities, and obligations of GCAHT shall not be the debts, liabilities and obligations of any of the Parties or personal debts, liabilities and obligations or the Directors, officers or employees of GCAHT; provided that a Party may, by an agreement separate from this Agreement, contract for, or assume responsibility for, specific debts, liabilities, or obligations of GCAHT.
  - 1. Indemnification. The GCAHT shall defend, indemnify and hold harmless each Party, its officers, agents, employees, representatives and volunteers (the "Indemnitees") from and against any loss, injury, claim, lawsuit, liability, expense, or damages of any kind or nature (collectively, "Claims") brought by a third party which arises out of or in connection with GCAHT's administration of this Agreement, including such third party claims arising out of or in connection with any Indemnitees acting within their authorized capacity as an officer, agent, employee, representative or volunteer of GCAHT. The GCAHT's duty to defend and indemnify under this Section shall not extend to Claims otherwise arising out of the Indemnitees' own active negligence, omissions or willful misconduct, whether in whole or part. The GCAHT shall finance its obligation pursuant to this Subsection by establishing a liability reserve fund, and/or by purchasing commercial insurance, and/or by joining a joint powers insurance authority ("JPIA") as determined by the Board. In the event the GCAHT's financial obligations to indemnify, defend and hold harmless, pursuant to this Subsection, exceed the liability reserve fund and/or the proceeds from any applicable insurance and/or JPIA coverage maintained by the GCAHT (hereinafter "Unfunded Liability"), a Party or Parties may meet and confer with GCAHT in good faith to negotiate alternative means or mechanisms by which GCAHT may fund such Unfunded

Liability; however, in no event shall the event of an Unfunded Liability relieve, limit or waive GCAHT's obligations of indemnity or defense to each Party as first set forth above in this Section. Nothing herein shall obligate any Party to indemnify or hold harmless GCAHT for any Unfunded Liability.

- 2. <u>Assignment.</u> Each Party shall assign to the GCAHT its rights, title, and interest to recover damages from any third party for Claims arising out of this Agreement, to the extent that the GCAHT has met its obligations to defend and indemnify such Party pursuant to this Section.
- 3. <u>Surviva</u>l. GCAHT's duty to defend, indemnify and hold harmless shall survive and continue in full force and effect after withdrawal of any Party from this Agreement, including as to the withdrawing Party, or termination of this Agreement for any reason with respect to any Claims that occurred before the date of such withdrawal or termination.

#### Section 10. Admission and Withdrawal of Parties.

- (a) <u>Admission of New Parties.</u> It is recognized that additional Parties other than the original Parties, may wish to join GCAHT. Any city within the Gateway Cities subregion may become a Party to GCAHT upon such terms and conditions as established by the Board of Directors. As a condition precedent to becoming a Party more than six months after the Effective Date, an eligible entity may thereafter become a Party to this Agreement; provided that (1) this Agreement is adopted by its governing body and (2) the eligible entity pays a late joining fee. The late joining fee shall be calculated by totaling the annual fee the eligible entity would have paid under this Agreement had it been a Party in all years prior and up until the Effective Date. Notwithstanding the foregoing, an eligible entity's late joining fee shall not exceed two times the amount of the applicable annual administrative fee existing at the time it becomes a Party. Payment shall be due within 30 days of receipt of an invoice from GCAHT.
- (b) <u>Withdrawal from GCAHT</u>. Parties may withdraw from GCAHT at any time upon their governing board's adoption of a resolution that so states the Party's intent to withdraw from GCAHT. The withdrawal of any Party, either voluntarily or involuntarily, unless otherwise provided by the Board of Directors, shall be conditioned as follows:
  - 1. In the case of a voluntary withdrawal, written notice shall be given to GCAHT six months prior to the effective date of withdrawal; and
  - 2. Unless otherwise provided by a unanimous vote of the Board of Directors, withdrawal shall result in the forfeiture of that Party's rights and claims relating to distribution of property and funds upon termination of GCAHT as set forth in Section 2 above. Withdrawn members shall not be entitled to any reimbursement of Fees.

#### Section 11. Notices.

(a) Notices required or permitted hereunder shall be sufficiently given if made in writing and delivered either personally or by registered or certified mail, postage prepaid, to the

persons and entities listed herein at the following addresses, or to such other address as may be designated to GCAHT on the Parties signature page for formal notice:

#### Section 12. Miscellaneous.

- (a) <u>Section Headings.</u> The section headings herein are for convenience only and are not to be construed as modifying or governing or in any manner affecting the scope, meaning or intent of the provisions or language of this Agreement.
- (b) <u>Counterparts.</u> This Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, but all together shall constitute but one and the same Agreement.
- (c) <u>Laws Governing</u>. This Agreement is made in the State of California under the Constitution and laws of such State and shall be construed and enforced in accordance with the laws of California.
- (d) <u>Severability.</u> Should any part, term, portion or provision of this Agreement, or the application thereof to any person or circumstance, be held to be illegal or in conflict with any law of the State of California, or otherwise be rendered unenforceable or ineffectual it shall be deemed severable, and the reminder of this Agreement or the application thereof to other persons or circumstances shall continue to constitute the Agreement the Parties intended to enter into in the first instance.
- (e) <u>Successors.</u> This Agreement shall be binding upon and shall inure to the benefit of the successors of the respective Parties. No Party may assign any right or obligation hereunder without the written consent of a majority of the other Parties.

# Part 1 – Introduction to the Gateway Cities Affordable Housing Trust

#### **Establishment**

On January 4, 2023, the Gateway Cities Council of Governments approved the formation of the Gateway Cities Affordable Housing Trust ("GCAHT" or "Trust"). The Trust is a joint powers agency, which may do any of the following: (1) fund the planning and construction of affordable housing of all types and tenures for persons and families of extremely low-, very low-, low-, and moderate-income as defined in Section 50093 of the Health and Safety Code; (2) receive public and private financing and funds; and (3) authorize and issue bonds, certificates of participation, or any other debt instrument repayable from funds and financing received and pledged by the Trust. The Trust may consist of any of the cities within the Gateway Cities Council of Governments, which is a joint powers agency representing a subregion of Los Angeles County.

The GCAHT was established on \_\_\_\_\_\_, by the execution of the Joint Exercise of Powers Agreement (the "Agreement") by and between the Cities of \_\_\_\_\_\_, \_\_\_\_\_, \_\_\_\_\_, \_\_\_\_\_, \_\_\_\_\_ (collectively, the "Cities"). These Bylaws were adopted by GCAHT's Board of Directors and provide for the organization and administration of GCAHT. These Bylaws supplement the Agreement.

# **GCAHT Guiding Vision and Mission**

A Steering Committee consisting of staff from various cities within the boundaries of the Trust along with individuals representing Los Angeles County, affordable financing, and affordable developers met on three separate occasions to discuss and recommend various governance, policy, and a guiding vision and mission as follows:

The vision of the Gateway Cities Affordable Housing Trust is to secure funding for the region that will increase the production of affordable housing and provide safe and quality homes for lower- and moderate-income individuals and families.

The mission of the Gateway Cities Affordable Housing Trust is to finance the development of affordable housing in the region and thereby increase the supply of housing to lower- and moderate-income individuals and families.

# **GCAHT Guiding Principles**

The guiding principles of the GCAHT:

- 1. Implement the findings and declarations of the Agreement.
- 2. Provide funding based on principles of fiscal responsibility and demonstrated value to the taxpayer and funder.

- 3. Retain local control and the ability for local governments to use GCAHT funding for housing solutions when needed, or to participate within the region as a whole.
- 4. Demonstrate accountability and transparency for parties to the Agreement and the public.
- 5. Promote public-private partnerships, nonprofit collaborations, and community building to maximize sources of public and private funds, when available, and to efficiently accelerate housing for moderate-, low-, very low- and extremely low-income individuals and families.
- 6. Provide opportunities to strengthen local partnerships and increase capacity of local cities and agencies engaged in fulfilling housing goals.
- 7. Commit to innovation and best practices in financing, production, and service delivery in supportive housing.
- 8. Serve the region's needs geographically by (1) extremely low-, very low-, low-, and moderate-income, and supportive housing types and (2) population.
- 9. Foster collaborative planning to allow for project prioritization and establish a pipeline of projects.
- 10. Provide access to funding to ensure that the Gateway Cities subregion receives the maximum benefit for the resources provided.
- 11. Incorporate County's Coordinated Entry System in conjunction with the cities' locally driven protocols to ensure that the developed housing resources has appropriately targeted and prioritized eligible homeless populations for each project.

# Part 2 – Bylaws of the Gateway Cities Affordable Housing Trust

# **ARTICLE I - Name**

The name of this entity shall be the "Gateway Cities Affordable Housing Trust" or "GCAHT" in these Bylaws.

# **ARTICLE II – Board of Directors**

#### **Section A: GCAHT Board of Directors**

1. All members of the Board of Directors must be from a city that is a party to the Agreement and shall be appointed as set forth in the Agreement.

2. Each of the nine (9) voting members of the Board of Directors of GCAHT shall be entitled to one (1) vote on the Board.

### Section B: Selection of Advisory Board Members

An Advisory Board may be appointed by the Trust Board consisting of various government staff, persons with housing development, housing services, finance, and development expertise.

All Advisory Board members are entitled to attend all GCAHT regular and special meetings and to fully participate in such meetings but shall not constitute voting members of the Board.

Advisory Board members need not be elected officials.

#### **Section C: Terms and Vacancies**

- Board of Directors: As set forth in the Agreement, terms of office for members of the Board of Directors shall generally be for two (2) years, subject to initial one (1) year terms for certain members as set forth in the Agreement. A Board of Director's seat shall be deemed vacant if he or she leaves elected office, or if his or her appointing body removes him or her. Upon a vacancy, the appointing body shall be notified and shall attempt to fill the vacancy within sixty (60) days of the vacancy occurring.
- 2. Advisory Board: Terms of office for members of the Advisory Board shall be for two (2) years. An Advisory Board member's seat shall automatically be deemed vacant if that member fails to attend three consecutive regular or special meetings. Upon a vacancy, the Trust Board shall be notified and shall attempt to fill the vacancy within sixty (60) days of the vacancy occurring.

# **ARTICLE III – Duties of Officers and Board Members**

#### Section A: Duties of the Board of Director Members:

- 1. Meet when called by the Chair to plan and coordinate the business and proposed activities of GCAHT;
- 2. Review and consider applications for project funding;
- 3. Review and consider GCAHT's financial information, including the Annual Financial Report, any related independent audit, and the GCAHT's annual budget; and
- 4. Serve on subcommittees or task forces when appropriate.

#### Section B: Formation of Subcommittees

The Board may create subcommittees or task forces to accomplish the goals and purposes of GCAHT.

## **ARTICLE IV – Meetings**

#### **Section A: Regular Meetings**

Regular meetings of GCAHT's Board shall be held once every two (2) months, unless otherwise called by the Chair. Meeting notice, agenda, and public comment procedures shall comply with the provisions of the Ralph M Brown Act. The Clerk of the Board shall prepare meeting agendas and handle noticing requirements.

#### **Section B: Special Meetings**

Special meetings of GCAHT may be held at any time upon call of the Chair, provided that the special meetings' noticing, and agenda complies with the Ralph M. Brown Act.

#### Section C: Voting on Project Funding

As set forth in the Agreement, every act or decision done or made by a majority of the Directors present at any meeting at which a quorum is present shall be the act of the Board of Directors. However, the Board should strive to attain a unanimous decision on all projects which receive funding from GCAHT.

#### Section D: Voting on Amending GCAHT's Bylaws, Principles, or Procedures

- 1. Amendments to GCAHT's Bylaws, Principles or Procedures shall be considered at a regular meeting and shall comply with the Ralph M. Brown Act.
- 2. An amendment to these Bylaws must be approved by a majority vote of the Board of Directors.

#### Section E: Minutes

The Clerk of the Board shall take minutes for GCAHT. A previous meeting's minutes shall be considered and approved at a subsequent meeting by a majority vote of the Board of Directors.

#### **Section F: Meeting Procedure**

The conduct of meetings shall be guided by Robert's Rules of Order (most recent published edition) where the question at issue is not determined by these Bylaws.

#### Section G: Location of Meetings

The Board must meet in publicly accessible places typical for hosting public meetings, such as Council Chambers or city community rooms.

# **ARTICLE V – GCAHT Board Code of Conduct**

This GCAHT Board Code of Conduct represents GCAHT's commitment to high standards of ethics, public service, collegiality, and transparency. The following standards should be regarded as minimum expectations for conduct. GCAHT Board Members will act in accordance with and maintain the highest standards of professional integrity, impartiality, diligence, creativity, and productivity. GCAHT will act in accordance with applicable federal, state, and local laws and regulations.

#### **Section A: Compliance with Policies**

Members of the Board of Directors and Advisory Board will conduct the GCAHT business in accordance with the Agreement, these Bylaws, and all adopted policies, including conflict of interest policies.

#### Section B: Conflicts of Interest

- The Board of Directors may not have a conflict of interest as determined by the California Political Reform Act (the "Act"), inclusive of the Levine Act, California Government Code section 81000, et. seq., and the regulations promulgated to effectuate the Act. Nor shall the Board of Directors have a conflict of interest under California Government Code section 1090.
- 2. Members of the Board of Directors are required to file a Statement of Economic Interest (Form 700) in the disclosure category as designated on the GCAHT Conflict of Interest Code.

# Section C: Confidentiality

Members of the Board of Directors and Advisory Board must maintain the highest standards of confidentiality regarding information obtained directly or indirectly through their involvement with the GCAHT. This includes but is not limited to information about applications for funding, GCAHT parties and their organizations and funded agencies. Members must also avoid inadvertent disclosure of confidential information through casual public discussion, which may be overheard or misinterpreted. Notwithstanding the foregoing, the GCAHT recognizes that excepting such confidential information which must be carefully preserved, the conduct of its business shall be open and transparent in accordance with the Ralph M. Brown Act and the California Public Records Act.

#### Section D: Gifts or Honoraria

It is not permissible for members of the Board of Directors and Advisory Board to offer or accept gifts, gratuities, excessive favors, or personal rewards intended to influence GCAHT decisions or activities.

#### Section E: Harassment

Harassment, interpreted as unwelcome conduct, comment, gesture, contact, or intimidating and offensive behavior likely to cause offense or humiliation, will not be tolerated and may result in disciplinary measures up to and including removal from GCAHT Board.

#### Section F: Laws and Regulations

GCAHT business will be conducted in a manner that reflects the highest standards and in accordance with all applicable federal, state, and local laws and regulations.

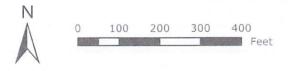

#### 203-17 CRACK SEALANT

#### 303-17.1 SMALL CRACK SEALANT

#### 203-17.1.1 GENERAL

Small crack sealant material shall consist of an asphaltic emulsion mixture used for filling/sealing cracks in asphalt concrete up to 1" wide.

#### 203-17.1.2 MATERIAL

The small crack sealant material shall comply with section 37-6.02 MATERIALS of the CalTrans Standard Specifications 2018 edition. Type 1 for Residential/Local Streets and Type 2 for Major Streets and larger. Material shall be per Caltrans Authorized Material List for Asphalt Concrete Pavement Crack Treatment or equal approved by the Engineer.

#### 303-17.2 LARGE CRACK SEALANT

**203-17.2.1 GENERAL** Large crack sealant material shall consist of an asphaltic emulsion mixture used for filling/sealing cracks in asphalt concrete 1-2" wide.

**203-17.2.2 MATERIAL** Material shall be per Caltrans Authorized Material List for Asphalt Concrete Pavement Crack Treatment or equal approved by the Engineer.

#### SECTION 302 ROADWAY SURFACING

Add the following sub-section:

#### 302-15 CRACK SEAL

#### 302-15.1 GENERAL

Crack seal material shall conform to 203-17 CRACK SEALANT.

#### 302-15.2 Site Preparation

Treat cracks from ¼ to 2 inch in width for the entire length of the crack. All cracks to be sealed shall be completely clean, dry, and free of all loose material, vegetation, and any other foreign substance which may cause the sealant not to adhere to the crack wall.

The Contractor shall treat all vegetation within the limits of the paved area to receive surface seal treatment with a post emergent herbicide. Herbicide shall be applied at least 5 (five) working days prior to sealing the street. Allowance for the five-day period shall be shown in the schedule required per Section 6-1, Construction Schedule and Commencement of the Work.

Cracks shall be cleaned using a hot compressed air lance (HCL) apparatus. The Contractor shall clean and dry all cracks with the HCL immediately before sealing. Air exiting the lance shall be heated to a

temperature sufficient enough to remove the oxidized surface from the crack walls. The HCL shall meet the following requirements:

- Compressed air capacity: 90 PSI min.
- Heated air temperatures: 600 F to 2,200 F
- Exit heated air: 1,000 ft/sec.
- Propane: 5 to 20 PSI

The joints and cracks shall be inspected and approved by the Engineer prior to placing the crack sealant material. Final joint and crack cleaning will be the same day of the sealing operation except as otherwise approved by the Engineer or his designee.

#### 302-15.3 Application

#### 302-15.3.1 Small Cracks (¼ - 1" Wide)

Sealant shall be prepared and applied to the pavement cracks in conformance with all manufacturers' instructions except where noted otherwise in this document.

- Sealant shall be applied when the pavement surface temperature is greater than 50°F.

- Containers of hot-melt rubberized sealant shall be delivered to the job-site in unopened containers that are clearly marked with data showing the manufacturer's name, the product designation and the manufacturer's batch number and lot numbers.

- The hot-melt rubberized asphalt shall be melted in a jacketed, double boiler type melting unit.

- Application of the hot-melt sealant shall be made with a pressure feed applicator or pour pot.

- Sealant shall be applied from the bottom of the crack up to the surface in a manner which does not result in sealant bridging or entrapping air pockets.

- Apply crack treatment with a nozzle inserted into the crack. The sealant shall be applied to a slightly overfilled condition and then leveled with a squeegee. The overband shall not exceed 1" on either side of the crack.

- If after two days the crack treatment is more than 1/4 inch below the specified level, the sealant fails, or the crack re-opens, re-treat the crack.

- Immediately remove crack treatment material that is spilled or deposited on the pavement surface. -Before opening to traffic, apply sand or the manufacturer's recommended detackifying agent to tacky crack treatment on the traveled way.

- Sweep up excess sand before opening to traffic.

#### 302-15.3.1 Large Cracks (1-2" Wide)

Sealant shall be installed per the manufacturer's recommendation.

#### AMENDMENT ONE TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE SIGNAL HILL COMMUNITY FOUNDATION AND THE CITY OF SIGNAL HILL

THIS FIRST AMENDMENT TO THE MEMORANDUM OF UNDERSTANDING ("Amendment One") is made effective as of this \_\_\_\_\_\_ day of March 2023, by and between the City of Signal Hill, a California municipal corporation ("City") and the Signal Hill Community Foundation ("Foundation"), a nonprofit organization. City and Foundation may each be individually referred to herein as "Party" and collectively referred to as "Parties" herein.

#### **RECITALS**

WHEREAS, the Foundation is a nonprofit organization with the public purpose as stated in Article III of the Foundation's Bylaws ("Bylaws"), to support the City in providing funding through grants, donations and corporate support for charitable, cultural, recreational and educational purposes to benefit the community within the present and future boundaries of the City; and

WHEREAS, on April 10, 2018, the City and Foundation entered into a Memorandum of Understanding ("MOU" or "Agreement") whereby the City designated the Foundation as a partner in providing opportunities and programs that contribute to the quality of leisure activities in the community, including but not limited to summer concerts in City park facilities and other community activities as determined by the Parties; and

WHEREAS, in exchange of the foregoing, and pursuant to the Agreement, the Foundation granted the City the authority to monitor Foundation budgets, funds, fundraising, spending and all Foundation activities, to require quarterly reports and audits of same and to provide input and comments to Foundation's Board of Directors on same, in order to ensure Foundation's funds are used for the public purposes described in the Agreement and in the Foundation's Bylaws; and

WHEREAS, pursuant to Section 6.1 of the Agreement, the Agreement shall terminate on April 10, 2023—five years from the date of the Agreement; and

WHEREAS, also pursuant to Section 6.1of the Agreement, the term of the Agreement may be extended for two (2) additional periods of five (5) years, provided that Foundation give notice to the City thirty (30) days prior to the end of the term of the Agreement; and

WHEREAS, the Foundation notified the City of its desire to extend the term of the Agreement for a period of five (5) years on March 8, 2023; and

WHEREAS, pursuant to Section 7.8 of the Agreement, the Agreement may be amended at any time by the mutual consent of the Parties in writing; and

WHEREAS, in this Amendment One, the Parties desire to extend the term of the Agreement by five (5) years, and amend several provisions of the Agreement specified below.

#### **TERMS**

NOW THEREFORE, in consideration of the foregoing recitals, mutual understandings, and other good, valuable and sufficient consideration, the City and Foundation agree as follows:

1. <u>Incorporation of Recitals.</u> The City and Foundation acknowledge that the above recitals are true and correct, and incorporate those recitals by reference into this Amendment One.

- 2. Section 1.1.4 of the Agreement is amended to read in full as follows:
  - 1.1.4. The Board is made up of not less than five (5) and not more than eleven (11) directors, one (1) of whom is Signal Hill Parks and Recreation Commissioner, one (1) of whom is a Signal Hill Council member, and nine (9) of whom are owners or employees of businesses doing business with or benefiting the City of Signal Hill and/or its residents, or Signal Hill city residents at large, as required by Article VII, Section 2 of the Bylaws. The Foundation Board shall vote to appoint 1 representative each from City Council and Parks and Recreation Commission to sit on the Board.
- 3. Section 2.1.1 of the Agreement is amended to read in full as follows:
  - 2.1.1 Subject to approval from the City's Parks and Recreational Commission, the City shall waive facility use fees for FOUNDATION's use of City parks and buildings ("City Facilities") to conduct programs and activities open for the general community. Subject to approval from the City Council, the City shall waive staff fees associated with Foundation's use of the City Facilities.
- 4. Section 2.2 of the Agreement is amended to read in full as follows:

2.2 Bricks/Tributes. City shall allow FOUNDATION to raise funds through sales of memorial bricks located at Hilltop Park, the Signal Hill Dog Park, and other areas as agreed upon by both Parties. FOUNDATION fundraising bricks shall be located in an area approved by the City Council. FOUNDATION shall use funds raised through sale of bricks for Signal Hill Public Library capital improvements and program support, and for other cultural, recreational, and educational purposes to benefit the community within the present and future boundaries of the City of Signal Hill, unless upon mutual agreement between FOUNDATION and City Council, additional uses are authorized, or unless Internal Revenue Service regulations provide otherwise.

5. Section 2.9.2 of the Agreement is amended to read in full as follows:

2.9.2 City shall be obligated to provide City staff assistance and City equipment to an extent that is reasonable in City's sole discretion. City represents that a reasonable amount of City staff assistance is approximately ten (10) staff personhours per month, but may be more or fewer hours under the particular circumstances.

6. Section 2.11 of the Agreement is amended to read in full as follows:

2.11 **Assistance with Mailers and Fliers.** City shall assist FOUNDATION with coordination of FOUNDATION fundraising mailers, flyers, and program creation as requested by FOUNDATION, and to an extent that is reasonable in City's sole discretion. All costs for printing and mailing such materials are to be paid by FOUNDATION. City represents that a reasonable amount of City staff assistance is approximately ten (10) staff person-hours per month, but may be more or fewer hours under the particular circumstances. City shall permit City's Mayor the City Council liaison to co-sign all FOUNDATION fundraising mailers, letters, and flyers.

7. Section 3.2.3 of the Agreement is amended to read in full as follows:

3.2.3 One fund category shall be for funds raised through the sale of bricks at designated City Facilities pursuant to Section 2.2 of this Agreement. All funds raised from such brick sales shall be placed in that fund category to be used for Signal Hill Public Library capital improvements and program support, and for other cultural, recreational, and educational purposes to benefit the community within the present and future boundaries of the City of Signal Hill, unless upon mutual agreement between FOUNDATION and City Council, additional uses are authorized, or unless Internal Revenue Service regulations provide otherwise. FOUNDATION shall maintain subsidiary detailed ledger records of revenues and expenditures resulting from brick sales at Hilltop Park, and shall provide a copy of those records annually to City.

8. Section 3.2.5 of the Agreement is amended to read in full as follows:

3.2.5 FOUNDATION shall ensure that that City receives at a minimum quarterly statements for the Foundation Account and that the filing of any taxes is completed in a timely manner and compliant with all applicable IRS regulations and deadlines.

9. Section 3.2.7 of the Agreement is amended to read in full as follows:

3.2.7 Not later than sixty (60) days prior to the close of each FOUNDATION calendar year (January-December), FOUNDATION shall prepare an annual FOUNDATION budget with anticipated expenditures and income for the upcoming calendar year and present the budget at a regular meeting of the Signal Hill Parks and Recreation Commission. The proposed budget shall contain all programs FOUNDATION expects to implement, the expected costs of all such programs, the schedule for carrying out such programs, all other expected costs, and all other spending FOUNDATION expects to occur in the fiscal year. FOUNDATION's presentation shall demonstrate how the budget meets the public purposes of FOUNDATION and the restrictions placed on FOUNDATION activities and expenditures under this MOU and the Bylaws. There shall be no requirement that the Parks and Recreation Commission or any other City person or entity approve the budget, and FOUNDATION shall in good faith consider City's

comments and may revise the budget accordingly prior to the beginning of the fiscal year.

10. Section 3.2.9 of the Agreement is amended to read in full as follows:

3.2.9 FOUNDATION shall permit City to address the Board at any time City wishes regarding any concerns or issues with FOUNDATION's budget, including submitting requests to the FOUNDATION for funding of programs, services, or offerings that meet the mission of the FOUNDATION.

11 Section 3.2.10 of the Agreement is amended to read in full as follows:

3.2.10 FOUNDATION shall obtain annual audits of FOUNDATION's funds, income, and expenditures, prepared by a local Certified Public Accountant. Not later than ninety (90) days after the close of each FOUNDATION calendar year, the completed audit shall be submitted to the City's Finance Department for review. The audit shall investigate and determine whether FOUNDATION's income and expenditures are consistent with the FOUNDATION budget and the restrictions placed on FOUNDATION activities and expenditures under this MOU and the Bylaws. There shall be no requirement that any City person or entity approve the audit. City may submit written comments to FOUNDATION regarding the audit, and FOUNDATION shall in good faith consider City's comments and may alter its practices accordingly.

12. Section 6.1 of the Agreement is amended to read in full as follows:

6.1 **Term**. Unless earlier terminated in accordance with Section 6.2 below, this Agreement shall continue in full force and effect for a period of ten (10) years from the date hereof. This Agreement may be extended for one (1) additional period of five (5) years by giving notice to City thirty (30) days prior to the end of the term or extension of term of FOUNDATION'S desire to extend.

13. <u>No Further Amendments.</u> Except as expressly stated herein, all other terms of the Agreement remain unchanged by this Amendment One.
